

# BCBC Councillor's Annual Report

This report identifies my key activities during the year ending 30<sup>th</sup>. April 2019. It is provided for the information of all constituents and for no other purpose. ## **Role & Responsibilities**

I was elected to Bridgend County Borough Council to represent Brackla on 4<sup>th</sup>. May 2017. I have undertaken a variety of roles within the Council over the past year including being appointed to several committees as listed below:-

Subject Overview & Scrutiny 3 (Chairperson)  
Development Control (Planning)  
Council  
Budget Research & Evaluation Panel (BREP)

I have supported the residents of my ward on a variety of issues and have formally raised 87 constituent queries with the Council and other organisations. This is in addition to informally addressing a number of other issues which you have asked me to help you resolve.

To enable me to fulfil my role as your representative, I have attended a number of Member Development Activities which have assisted me to ensure that my knowledge of national and local issues affecting the Council and my ward is maintained. In addition, I have endeavoured to keep up to date with the activity of local groups and organisations who help make Brackla a great place to live.

## **Constituency Activity** (max 200 words)

I have been available to discuss concerns raised by residents and continue to act on their behalf on a wide range of topics such as environmental concerns, road safety and police issues, litter and dog fouling enforcement, open space maintenance, highway matters, planning enforcement, children's services and social services. In fact, anything that a member of the public has a problem with or a query about I will always endeavour to help. I may not have been able to resolve every query in accordance with the wishes of the constituent, but I have tried my best. The Brackla PACT meetings have not been as regular as usual but I have endeavoured to attend as many as possible and been active in the discussions with community members and the local police on relevant issues following each PACT meeting.

In addition to being elected to Bridgend County Borough Council on 4<sup>th</sup>. May 2017, I was also elected to Brackla Community Council and in May 2019 I am hoping to become the Chair of the Community Council for the 3<sup>rd</sup>. occasion in over 20 years. While the Community Council does not have a wide range of powers or responsibilities, there are many activities undertaken by the Community Council such as the flower displays, grass cutting, litter bins and general environmental improvements and I hope residents can see the difference it makes within the local community. The Council will again be entering the Wales in Bloom competition in 2019 and hoping for a positive result.

I am also a Local Education Authority Governor at both Brackla Primary School and Tremains Primary School, and previously served on Brynteg Governors and a short period at Archbishop McGrath School.

**Initiatives and Special Activities** (max 200 words)

Since January 2017 I have been an active and founder member of Brackla Environmental Support Team (B.E.S.T.). This voluntary group undertakes regular litter cleansing sessions and environmental clean ups and has cleaned and painted several bus shelters and planted daffodils at many of the street signs.

We are fortunate in Brackla to have a local nature reserve at Tremains Wood and over recent months I have been actively involved with the newly formed Tremains Woodland Rangers who are doing a great job in protecting and enhancing this ancient woodland in the centre of Brackla.

I have regularly supported and helped organise the Brackla Fun Day since its inception in 1998 and this continues to be a great success each year and is fully funded by Brackla Community Council for all of the community to enjoy.

Wherever possible I try to communicate via email and / or telephone but have also made home visits to discuss concerns with residents who prefer to speak with me in person on a confidential basis.
