The Committee noted with pleasure the fact that the Development Control Section were continuing to meet the Government target of determining 80% or more applications within an eight week period, and that for the period January - March 2011, Bridgend were the lead Authority in Wales in terms of the percentage of planning applications processed expeditiously.

579 <u>BRIDGEND TOWN CENTRE CONSERVATION AREA: CONSERVATION AREA</u> <u>MANAGEMENT PLAN</u>

The Corporate Director - Communities submitted a report, the purpose of which, was to seek Members approval for the revised Management Plan for Bridgend Town Centre Conservation Area, attached to the report at Appendix 'A'.

The report advised that the Conservation Area Management Plan had been prepared, and this set out the Council's general approach to addressing a range of issues affective the character and appearance of the conservation area. It also identified actions, including the preparation of design guidance, to inform future

planning policy and planning decisions to ensure the conservation area's preservation or enhancement. This was balanced with a need to maintain the economic prosperity of the town centre, and to facilitate the continued use of historic buildings.

The report explained the impact Phase I of the Townscape Heritage Initiative Scheme has had upon the successful regeneration of the town centre, and that Phase II of the Scheme had recently commenced following a further grant approval of £532k from the Heritage Lottery Fund.

Members would be aware that approval had previously been given by Committee for the draft Conservation Area Management Action Plan and action programme, but this had subsequently now been revised.

Members commented upon the Plan and suggested that Paragraph 3.4 should be supplemented to include addressing problems associated with fly posting and graffiti.

Further information was also requested regarding listed buildings, and the Team Leader Conservation explained that this information would be contained in a future report to Committee in the autumn, which would also include details of any avenues of funding to improve or maintain these structures.

RESOLVED: That the Development Control Committee approved the

Management Plan for Bridgend Town Centre Conservation

Area for interim development control purposes.
