11 ELECTRONIC NOTIFICATION OF DECISION NOTICES

The Development Control Manager reported that the Government was encouraging Local Planning Authorities to adopt e:government practices in the interests of efficiency. He stated that this Local Planning Authority had adopted numerous e:government practices to increase efficiency and make a considerable amount of planning information readily accessible to the public.

Article 32(1)(a) of the Town and Country Planning (Development Management Procedure) (Wales) Order 2012 states that where an application is made using electronic communications the applicant is taken to have agreed to the use of such communications by the Authority for the purposes of the application.

The Development Control Manager reported that one area where e:government is used by this Council is through the receipt of planning applications electronically through the Planning Portal. The number of applications submitted through the Portal had increased from 20% to 30%, with the last available figures for February 2012 showing a submission level of just below 50%.

The Development Control Manager reported on a proposal to reduce officer time in printing paper decision notices and plans and to save on postage with applicants/agents being advised of decisions electronically, where they had provided an e:mail address. The decision notice and determined plans would be available for inspection and downloading online.

RESOLVED: That the report of the Corporate Director - Communities to further extend e:government practices be endorsed.

12 SITE VISIT PANEL

The Group Manager Development reported on a proposal to approve the membership of the Site Visit Panel which comprised three Members, the Chair and Vice-Chair of the Development Control Committee and one other Member. In addition a reserve Member would need to be appointed.

The Group Manager Development outlined to the Committee the protocol for site inspections, which were essentially fact finding exercises. Site visits were not part of the formal Committee meeting, with public rights of attendance not applying. Their purpose was for officers to point out relevant features of sites and to enable questions to be asked on site for clarification. Discussions on applications would only take place at the subsequent Committee meeting.
