  - (i) Provide 100% of the dwellings on the site as affordable dwellings in accordance with the definitions contained in the Council's Supplementary Planning Guidance (SPG) 13 Affordable Housing.
  - (ii) Provide a financial contribution of £150,000 towards the provision of primary school education.
  - (iii) Provide a financial contribution of £37,000 toward the provision of public open space and associated facilities to serve the proposed residential development in the North East Brackla Development area.
- (3) That any consent so granted be subject to the Conditions contained within the report.
