**HIGHWAYS (ROAD HUMPS) REGULATIONS 1999
PROPOSED CONSTRUCTION OF TRAFFIC CALMING PLATEAU**

Planning consent has been granted to Redrow Homes for the construction of residential properties on a site to the south of Fulmar Road, the access to which will be off Sanderling Close.

As part of the development, in the interests of highway safety, it is proposed that traffic calming measures will be introduced at appropriate intervals along the road through the new site. To complement the scheme by providing additional measures at the start of the access road to the development, it is proposed that a raised platform will be constructed on the carriageway and on the immediate approaches to the 'crossroads' junction with Sanderling Close, The Whimbrels and Tern Road to form a 'road hump plateau'. The attached Drawing Number T/05/2/01 refers.

In accordance with the Highways (Road Humps) Regulations 1999, I shall be glad to receive your observations on the proposed measures within 3 weeks of the date of this letter.
