TRAFFIC ORDER 2006

NOTICE IS HEREBY GIVEN that Bridgend County Borough Council proposes to make an Order in exercise of its powers under Section 1(1), 2(1) to (3), 3(2) and 4(1) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 of the Act the effect of which will be to:-

1. Prohibit except upon the direction of a Police Constable in uniform or a Traffic Warden, the waiting loading and unloading of any vehicle at any time along the length of road and sides of lengths of roads specified in the Schedule to this Notice. Nothing in the above shall render it unlawful to cause or permit any emergency services vehicle to wait on the length of road and sides of lengths of roads. Exemptions will also be provided to enable vehicles used for the purpose of building and road works, the maintenance, improvement, reconstruction, inspection or survey of the lengths of roads and sides of lengths of roads, river bridge or river embankment, the maintenance of essential services and to enable a person to board or alight the vehicle to wait on the length of road and sides of length of roads.

A copy of the proposed Order and map showing the road and sides of lengths of road to which the proposed Order relates and a statement of the Council's reasons for proposing to make the Order may be inspected at the offices at Bridgend County Borough Council between the hours of 9.00a.m. to 1.00p.m. and 2.00p.m. to 5.00p.m. Monday to Thursday and 9.00a.m. to 1.00p.m. and 2.00p.m. to 4.30p.m. on Friday.

Objections to the proposal together with the grounds on which they are made must be sent in writing to the undersigned by the 26th May 2006.

SCHEDULE

(Lengths of roads and sides of lengths of roads)

The north western side of Plasnewydd Street, from its junction with the western side of the lane leading to Plasnewydd Junior School to its junction with the unnamed Lane leading to Talbot Street (alongside number 12 and number 15a Talbot Street) a distance of approximately 18 metres.
