- 4. A copy of the proposed Order and map showing the lengths of road and sides of lengths of roads to which the Order relates and a statement of the Council's reasons for proposing to make the Order may be inspected at the address below during normal office hours.
- 5. Objections to the proposals together with the grounds on which they are made must be sent in writing to the undersigned at the below address by the 20th February 2013.
