REPORT OF THE CORPORATE DIRECTOR - CHILDREN

PERFORMANCE DATA UPDATE

1. Purpose of Report.

The Welsh Assembly Government has recently released data on adoptions, outcomes and placements for Children Looked After by Local Authorities for the year ending 31st March 2010. This report will provide information to Members regarding the national and local performance indicators.

2. Connection to Corporate Improvement Plan / Other Corporate Priority.

Looked After Children are a key responsibility for the Council as corporate parents and, as such, are included within the following community strategy themes:

- Young Voices,
- o Healthy Living,
- New Opportunities.

3. Background.

The Safeguarding and Family Support Service is required to provide data to the Welsh Assembly Government to evidence its performance against a number of key indicators. Within the service a number of these performance indicators are monitored on a monthly basis to ensure compliance and track progress as well as identification of any areas for further attention. They are reported on routinely within the Quarterly Business Review and to our Continuous Improvement Board as well as to members.

4. Current situation / proposal.

The key points from the latest release are that, across Wales:

- there was a 10 per cent increase in the number of children looked after at 31 March 2010 over the previous year (excluding short-term or respite care);
- approximately 10 per cent of children looked after at 31 March 2010 had three or more placements during the year;
- Key Stage assessments and GCSE results improved over the previous year;
- local authorities were in touch with 95 per cent of 19 year old care leavers; 47 per cent of these young people were in education, training or employment.

There are 27 core and strategic performance indicators which relate to looked after children. Of these, performance in Bridgend improved across 14 on the previous year,

was worse in 8 and had no change for 2. The remainder were not reported on in previous years so there is no comparative data available. (see table 1).

For a large number of these performance indicators, Bridgend performed above the Welsh average. It is also important to consider that for some PIs where there are small numbers of children or young people being considered, changes can cause a significant impact on the percentage increases or decreases e.g. young adults (care leavers) over the age of 19 that we are still in contact with. Large percentage changes may only relate to 4 or 5 people a year. The table includes commentary alongside details of Bridgend's performance.

As previously reported and shown in table 2, Bridgend's LAC population has increased by nearly 14% and our neighbours also saw rises, some, such as NPT and Swansea, were significantly larger than others. CSSIW inspections have been critical in some authorities of the overuse of informal arrangements for care. This is not the case now in Bridgend.

As table 3 shows, of the 22 authorities, all but 4 have more boys in care than girls. Bridgend follows this norm. Two significant groups with a high number of children aged 0 to 4 were becoming looked after but, in the selection of authorities above, it is the 10 to 15 age group that dominates. This is sometimes as a result of abuse or neglect but can also be about rejection by parents and family breakdown. This, combined with increasing alcohol and drug misuse by younger teenagers, is making some of them more vulnerable to emotional difficulties.

5. Effect upon Policy Framework& Procedure Rules.

There is no effect upon the Policy Framework and Procedure Rules.

6. Equality Impact Assessment

This report is concerned with performance information rather than policy or decision making. Each looked after child's needs are identified on an individual basis; hence an equality impact assessment is not applicable.

7. Financial Implications.

The increase in the number of looked after children and the use of independent foster placements continue to create volatility within the budget of the Safeguarding and Family Support Service. This is alongside an increase in the number of care proceedings and the costs incurred for the Authority's Legal Service when making such applications.

8. Recommendation.

It is recommended that the Committee notes this report on the performance of the Safeguarding and Family Support Service in meeting the needs of children and young people within its care against the other 21 authorities in Wales.
