REPORT OF THE CORPORATE DIRECTOR - CHILDREN

LOST AFTER CARE

1. Purpose of Report

1.1 To provide Corporate Parenting Cabinet Committee with information about the recently published report, 'Lost after Care', and to explain how 'My Planner' will be implemented to enhance work with care leavers known to Bridgend.

2. Connection to Corporate Improvement Objectives / Other Corporate Priorities

- 2.1. As the report will refresh and build upon existing knowledge and the planner represents a tool for young people, our view is that dissemination of the report and using the planner will enhance all areas aimed at improving outcomes for older looked after young people. The area of work falls within the Children Act 1989 and the Children (Leaving Care) Act 2000 which enshrines the following broad principles:
 - to delay young people's discharge from care until they are prepared and ready to leave;
 - to improve the assessment, preparation and planning for leaving care;
 - to provide better personal support for young people after leaving care;
 - to improve the financial arrangements for care leavers.
- 2.2 Cabinet members may wish to also consider this report in light of the 2009 Welsh Government and Welsh Local Government Association document, 'If this were my child. A councillor's guide to being a good corporate parent'
- 2.3 The report is relevant to the Young Voices priority in the Council's Corporate Plan.

3. Background

- 3.1. During July 2011, Gwenda Thomas, Deputy Minister for Children and Social Services at Welsh Government wrote to Local Authorities highlighting that the report 'Lost After Care' had been published and recommended that the accompanying Planner be adopted. The documents arrived in Bridgend in September 2011 and have already been disseminated.
- 3.2 The report itself was coordinated by the Children's Commissioner's Office and is endorsed by Keith Towler (Children's Commissioner for Wales). It is informed by contributions from looked after young people, their social workers and other key professionals including young peoples' carers, elected members, Welsh

Government, heads of service and Fostering Network. The report can be found at:

- 3.3 'Lost After Care' illustrates the experiences of older looked after young people and the difficulties they face when they start planning their move into independent living. Although it contains many examples of professionals and practitioners carrying out their duties diligently, the report also highlights the disparity in services and information provided to this vulnerable group of young people.
- 3.4 Of particular resonance to the Safeguarding and Family Support Service was the importance that young people place upon time spent with their social workers in order to resolve issues and make sound plans for the future, for example, the report states that:

The relationship between the young person leaving care and their social worker is fundamental to that young person being properly supported and guided through the transition from care to independence....Chief amongst the reasons for the young people expressing dissatisfaction with their social worker would appear to be the lack of time spent with the individual young person, coupled with a lack of understanding about what the young person really wanted.

- 3.5 We are equally struck by the experience of poverty that care leavers describe in this and other studies. We are keen to use the report as a catapult to further enhance the quality of our care planning long before care leaving is a consideration in order to give young people the best chance possible to draw upon the emotional and practical skills that they require to move towards stability as an independent adult.
- 3.6 The 'My Planner' document arises out of the study and is a paper tool aimed at increasing young people's understanding of their rights and entitlements. It can be found at:

- 3.7 'Lost After Care' suggests a number of service improvements to facilitate a better coordinated response in identifying and responding to the rights and entitlements of young people moving on to independent living. Theses are considered in section 4 of the report.

4. Current Situation / Proposal

4.1 Practice in Bridgend is compliant with the Children (Leaving Care) Act 2000 Guidance Wales. In Bridgend, there are currently 126 young people open to the Leaving Care Team. Each young person known to the Leaving Care team has a personal adviser and the team works with a range of statutory, independent and third sector services in aiming to achieve best outcomes for care leavers. Pathway plans are informed by a needs assessment that is carried out in partnership with the young person and reviewed by an Independent Reviewing Officer at statutory intervals.

- 4.2 'My Planner' is being disseminated to all young people who are known to the Leaving Care Team. It will be shared with young people who become known to the team as part of the needs assessment. This will allow workers to use My Planner as a feature of their work aimed at informing young people about their rights and entitlements.
- 4.3 There are 29 priorities for improvement recommended by 'Lost After Care'. The first six relate to actions required by Welsh Government and CSSIW. We have highlighted in Appendix 1 a table that includes the priorities that concern elected members and officers of the Council. The table is populated where existing practice meets with the 'Lost after Care' recommendation. For those areas where further work is required, a meeting will take place in early 2012 in order to fully populate the table and ensure that practice within Bridgend is either compliant with or better than the priorities identified. This will be attended by relevant managers from Safeguarding and Family Support and Councillor Alana Davies, the lead member for children.
