HALF-YEARLY REPORT – IMPLEMENTATION OF THE COUNCIL'S WELSH LANGUAGE SCHEME 2008-2011

1. Purpose of Report.

- 1.1 To update the Committee on progress with implementing the Council's Welsh Language Scheme 2008-2011.
- 2. Connection to Corporate Improvement Plan / Other Corporate Priority.
- 2.1 The Welsh Language Scheme is a statutory scheme on a cross-cutting issue, and therefore impacts upon the work of the whole council. It is linked to the equality agenda, and is a key component in delivering the council's Customer Care Programme.

3. Background.

- 3.1 On 10 September 2008, the Council approved the revised Welsh Language Scheme 2008-2011. The revised Scheme aims to address areas of development suggested by the Welsh Language Board, based on statutory guidance issued by them.
- 3.2 The Welsh Language Board suggested that the council must demonstrate improvement in the following key areas:
 - The production of a bilingual website
 - Bilingual job advertising
 - Staff development (i.e. training to support availability of Welsh-speaking staff in key services)
 - Performance monitoring.

4. Current situation / proposal.

4.1 Progress in the current financial year is outlined in Appendix A; this includes all milestones for 2010-11, plus milestones that have slipped from previous financial years.

The Council has made particular progress in the following areas:

 Website – significant resources have been devoted to producing a bilingual website, which is now functional.

- Skills Strategy this is a "working document" to implement staffing aspects
 of the Welsh Language Scheme. It has been finalised in consultation with
 the Welsh Language Board.
- Training & development a training needs survey was conducted with managers across the organisation. Further to this, a number of Members and staff have enrolled on courses for learners, and a focus group was recently conducted with fluent staff to explore their development needs.

The Council has also co-operated with the Welsh Language Board to assist them with their compliance checks of bilingual public notices, bilingual websites and bilingual elections literature. The council has also responded to consultation exercises by the Welsh Language Board and Welsh Assembly Government.
