107 Cwrt Coed Parc, Maesteg, Bridgend - Change of use of existing dwelling to 4 self-contained apartments.

Subject to the amendment of Condition 1 to the report as follows and to the inclusion of further Notes (e), (f) and (g):-

Condition 1:

No works shall commence on site until such time as a scheme showing 6 off street parking spaces and an enlarged turning head (measuring a minimum of 4.5m across the eastern edge of the turning head) has been submitted to and agreed in writing by the Local Planning Authority. Such scheme shall be implemented as agreed before beneficial use of the first apartment, with all bays and enlarged turning head completed in permanent materials and retained thereafter otherwise agreed in writing by the Local Planning Authority.

Reason: In the interests of highway safety.

(Policy H5 - Bridgend Unitary Development Plan)

Notes:

- (e) Condition 1 will require the removal/setting back of the site boundary adjacent to the north eastern edge of the existing turning head to facilitate the required enlargements. A replacement parallel 6m parking bay could be provided on this area of the site,

adjacent to the turning head, replacing the sub-standard space proposed.

- (f) The developer should make every effort to ensure surface water, from any permanent surface, drains onto adjacent porous surfaces, thereby reducing the demand on the drainage system. Alternatively, the developer may wish to explore the use of permeable materials for the parking areas, although compacted chippings would not be considered acceptable as they are likely to be dragged onto the road/footway to the detriment of the general safety of users. As a result of the above, impermeable surfacing such as concrete or tarmac extending across the full width of the parking areas should not be considered as a first option.
- (g) Rainwater run-off shall not discharge into the highway surface-water drainage system. Failure to ensure this may result in action being taken under Section 163 of the Highways Act 1980.
