LICENSING FUNCTION

DISCRETIONARY LICENCE FEES AND CHARGES

Councillors W B Evans and R D Jenkins had earlier declared an interest in the report, for the reasons so given.

The report attached an Appendix 1, which included discretionary fees in relation to Miscellaneous Premises, Hackney Carriage and Private Hire Licences and

Miscellaneous Licences and Permits. So as to allow the above Members to participate in that part of the report which related to issues other than taxis, Members decided to consider the fees relating to Hackney Carriage and Private Hire vehicles first.

Councillor Evans and Councillor Jenkins left the meeting whilst these fees were being discussed. Both Members returned to the meeting for the remainder of the item which they did not have an interest in, i.e. discretionary fees relating to Miscellaneous Premises and Miscellaneous Licences and Permits.

The Deputy Chief Executive and Executive Director - Resources submitted a report, the purpose of which, was to determine licensing fees and charges for 2006/07.

The Licensing Officer gave a resumé of the report, starting off with some background information, including powers available to the Licensing Committee in relation to the setting of various fees and charges.

The Licensing Officer then alluded to budget issues (for 2006/07) which included an explanation as to why the fees needed to be revised. This part of the report also referred to the requirement of further licensing staff, i.e. in the form of Enforcement Officers.

The report then gave some information on fees for Street Trading Consents (previously requested by Members) including any policy issues that may be adopted under the appropriate legislation.

In relation to the layout of the report, Members felt it would be beneficial if, in the future, reports on fees and charges could be split to include two separate items, one in relation to fees and charges for taxis and the other miscellaneous premises and miscellaneous licences and permits. Officers agreed to follow this suggested process for future such reports.

It was suggested that Officers pursue the appropriate channels, in a bid to secure extra staff in the Licensing Section, i.e. Enforcement Officers, for reasons given earlier at the meeting and outlined in the report.

A request was also made from the floor for information to be provided to Members of the Committee, on how much organisers of town market events charge individual stall holders for erecting a stall in town on these days. It was further requested to provide information confirming where this money also goes. Again Officers agreed that this would in turn be provided to Committee Members.

RESOLVED: (1)

- That Committee approves the proposed fee increases to be effective from 17 July 2006, with the exception of fees relating to taxi vehicle licences and operator licences which are subject to Public Notice and will become operative either 28 days following the expiration of the Public Notice, or, if objections are received, on a date to be determined by the Licensing Committee, following formal consideration of the objections.
- (2) That Committee adopts a policy in relation to Street Trading whereby the Licensing Sub-Committee may consider applications for reduced fees based on the

following criteria and subject to the appropriate evidence being submitted as to the status of the organisation:-

- (a) registered charity
- (b) other 'not for profit' organisations
- (3) That the above be subject to a £30 fee being charged for each annual consent to cover costs.
- (4) That a further report be presented to the Committee should the trend in street trading enquiries change.
- (5) That Officers pursue via the appropriate channels, concerns raised by Members regarding a probable shortage of Enforcement Officers currently within the Licensing Section, and that a further report be awaited on this matter.
