# REPORT OF ASSISTANT CHIEF EXECUTIVE LEGAL AND REGULATORY SERVICES

#### 1.0 LICENSING FUNCTION:

LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1976: DISCRECTIONARY LICENCE FEES AND CHARGES

#### 1.1 Purpose of report

1.2 To report an objection to the bringing into effect of an increase in fees relating to vehicle and operator licences for the year 2008/2009.

### 2.0 Background

- 2.1 The proposed fee increase was published in the Glamorgan Gazette in accordance with statutory requirements. The relevant vehicle and operator licence fees are attached at Appendix A.
- 2.2 Following expiration of the period for Public Notice, one letter of objection has been received which is attached at Appendix B.

#### 3.0 Comments on objection

- 3.1 The objection is based on the contention that the licence fees for vehicles has increased by over the rate of inflation quoted by the objector as 3.5%.
- 3.2 The proposed increases for hackney carriage, private hire and specialist vehicles were calculated in line with the Council's budget strategy which approved an increase in licensing fees by 5% at Council on 13 February 2008.
- 3.3 The proposals originally recommended are necessary to recover the cost of providing the service. These include the administration and enforcement of taxi vehicle licensing.

#### 4.0 Legal Implications

The proposals recommended within the report are necessary for the administration of licensing functions.

## 5.0 Financial Implications

The recommended increases will enable the service to meet inflationary increases in administration and enforcement costs.

#### 6.0 Recommendation

That the proposed increases in fees are approved with effect from 18 September 2008.
