58 <u>LICENSING COMMITTEES AND SUB-COMMITTEES</u>

The Licensing and Registration Officer presented a report which requested that the Licensing Committee form two Sub-Committees of seven members, each to be chaired by either the Chairperson or Vice-Chairperson of the Licensing Committee where possible. These Sub-Committees designated as Sub-Committees A and B would sit to consider taxi licensing and street trading applications and Gambling Act matters.

A further Sub-Committee would be formed when needed to deal with applications under the Licensing Act 2003. This would comprise no more than three members of the Licensing Committee and where possible would be chaired by the Chairperson or Vice-Chairperson of the Licensing Committee. The remaining Members would be selected on a rota basis preferably from either the A or B Sub-Committees to simplify the minute approval process but it can be a mix of A or B if there is difficulty in gathering a sub-committee.

Members were provided with a suggestion for the membership of each of the Sub-Committees based on a geographical spread. Members queried if it was of greater benefit to have the local Members in attendance at meetings where their local knowledge would assist the licensing process. The Legal Officer informed Members

that applications were considered against Licensing Objectives and the use of historical local information would not be appropriate.

The new Members to the Licensing Committees queried the availability of training. The Licensing and Registration Officer informed the meeting that dates for a training session would be circulated at the earliest opportunity. This session would act as an induction for new Members and refresher training for the more experienced members.
