### 83 COMPOSITION OF LICENSING COMMITTEE AND SUB-COMMITTEES A & B

The Assistant Chief Executive - Legal and Regulatory Services submitted a report, the purpose of which was to propose the membership of the two Licensing Sub-Committees A and B, consisting of seven Members of the Licensing Committee and chaired, where possible, by the Chairperson and Vice-Chairperson of that Committee. In the event that the Chair or Vice-Chair are unable to attend a Licensing Sub-Committee meeting, a Chair will be elected from those Members in attendance. The remit of these Sub-Committees would be to undertake all general licensing functions, including taxi licensing.

The exception would be those falling within the purview of the Licensing Act 2003, which have special requirements relating to the formation of Sub-Committees. To this end, Panels of Special Licensing Sub-Committees consisting of three Members, chaired by the Chairperson and the Vice-Chairperson, using Licensing Sub-Committees 'A' and 'B' on generally a rota basis would be used.
