- 1. Purpose of Report
- 1.1 This is an application made by Annette Emalene De Graaf for a new Premises Licence for the above premises.
- 2. Connection to Corporate Improvement Plan / Other Corporate Priority
- 2.1 None.
- 3. Background
- 3.1 A copy of the application form is attached at Appendix A together with a location plan. A full sized copy of the plan indicating the proposed licensed area will be available at the meeting.
- 3.2 The application has been advertised in accordance with Regulations.
- 4. Current situation / proposal.
- 4.1 Representations have been received from the Chief Officer of Police, Licensing Authority and a member of the public. Copies of the representations are attached at Appendix B, C and D. Copies of the representations received have been forwarded to the applicant for consideration.
- 4.2 The representations submitted by the Public Protection Department have been withdrawn. An agreement has been reached with the applicant and the application has been amended as follows:-

- 1. The premises licence holder will undertake routine monitoring of the external area to monitor and control the noise from any patrons outside the premises.
- 2. There shall be no drinks consumed outside the curtilage of the premises.
- 3. There shall be no licensable activities outside in the rear courtyard area.
- 4. No drinks shall be consumed in the rear courtyard area after 21:30.
- 5. All litter, including cigarette ends, shall be cleared from the front pavement area in front of the premises and to the rear lane of the premises as shown on the attached plan A at the close of business each day.
- 4.3 The Licensing Section is aware that there have been discussions between the applicant, South Wales Police and the Licensing Authority but no agreement has been reached at the time of preparing this report.
- 4.4 The Planning Department has submitted the following information in the form of an observation only:

"P/03/373/FUL – The use hereby permitted shall not be open to customers outside the following times:-

0900 – 1800 hours Monday to Sunday

Reason: In the interests of residential amenities".

- 4.5 The Sub-Committee must have regard to the Council's Statement of Licensing Policy and the Home Office Guidance issued under Section 182 of the Licensing Act 2003. However, the Sub-Committee must consider each application on its own merits having regard to the application, the operating schedule submitted and the representations made.
- 4.6 Sections 2, 8, 9, 10 and 13.57 of the Home Office Guidance apply to this application. There are no specific local licensing policies applicable to the Porthcawl area.
- 5. Effect upon Policy Framework & Procedure Rules.
- 5.1 None
- 6. Equality Impact Assessment.
- 6.1 A full Equality Impact Assessment has not been undertaken in relation to this service, however due regard has been given to the implications on persons protected by equality legislation and human rights. Adverse impact of this Legislation on the equality protected groups is very unlikely. Consideration has been given to the guidance issued to accompany the Licensing Act 2003 relating to need to eliminate duplication and conflict with existing disability legislation and to reference and highlight the Council's Race Equality Scheme, polices and codes of conduct to applicants. We do not consider, on the basis of the above, that a detailed Equality Impact Assessment is required for this service. In line with our Inclusive Equalities Scheme we will monitor for any adverse impacts that may develop.

- 8. Recommendation.
- 8.1 The Sub-Committee is asked to determine the application having regard to the Council's Statement of Licensing Policy and the Guidance issued by the Home Office.
- 8.2 The Sub-Committee is requested to confirm whether any additional conditions are to be imposed or only those which are consistent with and set out in the operating schedule. Sections 10.8, 10.9 and 10.10 apply to the imposition of conditions. Mandatory conditions will apply to the licence, if granted, in respect of the specification of a Designated Premises Supervisor, age verification policy and authorisation by personal licence holders.





M Describe the steps you intend to take to promote the four licensing objectives:

#### a) General – all four licensing objectives (b, c, d and e) (please read guidance note 9)

The types of regulated entertainments proposed enhance and augment the normal food catering facility. Staff will be trained on the requirements of the Licensing Act 2003 when they are recruited. No new steps have been identified by risk assessment in relation to the four licensing objectives except as below. We have considered the terms of your local Licensing Policy in preparing this application.

#### b) The prevention of crime and disorder

Insofar as may be relevant, given that the provision of alcohol is secondary to the provision of food, to provide a 30 minute extension to opening hours after the end of alcohol sales with access to the Premises toilet facilities and the provision of non-alcoholic refreshment during such period.

It is intended that the Personal Licence holder will be present on the Premises whenever trading and if for any reason the Personal Licence holder herself cannot be present then written authority will be given by the DPS to another appropriate person trained in the requirements of the Licensing Act 2003 or a personal Licence Holder in their own right. No less than five working days written notice will be given to the polce if required when "Events Days" are planned.

The DPS is prepared o be a member of the local Pubwatch scheme.

#### c) Public safety

Normal catering numbers will not be exceeded and for functions the numbers will be limited to 75 persons or such other number as the consultative authorities shall determine. No specific risks regarding public safety have been identified. In the very unlikely event that a risk of overcrowding is identified (i.e on Event Days) the DPS will liaise with both the police and the fire authority to discuss how best to deal with any issue.

The Applicant and her staff will continue to assess all aspects of the Health & Safety at Work etc Act 1974 and prominent signs relating to nearest fire exits will be displayed together with a notice of the fire policy to be adopted in the event of an emergency.

#### d) The prevention of public nuisance

All windows will be kept closed after 23.00.

All amplified music shall be inaudible at the façade of the nearest residential premises after 23.00

There shall be no removal of waste bottles after 23.00

Any live music will end at 02.00 except on Ban Holidays, New Years Eve and New Years Day

e) The protection	of children from harm				
The restrictions set out in the Licensing Act 2003 will apply. Photographic proof of age will be required to be shown by anyone seeking to purchase alcohol who appears to be under 20 years of age. No unusual risks to children have been identified albeit children will be permitted into the dining area with responsible adults taking meals.

#### REPRESENTATIONS

South Wales Police make representations to the Bridgend County Borough Licensing Authority that they are of the view that the likely effect of the grant of this application on the licensing objectives would be to increase crime and disorder and public nuisance at or in the vicinity of the premise.

Furthermore approval would fail to protect children from harm.

The representations are strengthened having regard to the steps intended to be taken in the Operating Schedule to promote the licensing objectives.

Information and evidence is set out below for the Licensing Sub-Committee's consideration.

#### THE PREMISE

The Olivias Coffee House is currently open and trading as a restaurant in Porthcawl town centre without a premises licence. Customers therefore cannot consume hot food after 23.00 hours or be sold alcohol. They bring their own alcohol and the premises supplies the diners with glasses. Regulated entertainment is also provided on a weekend by way of a live acoustic music set. The premise operates primarily as a 'Tapas bar' where customers may dine at the premise.

This application to grant a premises licence at this premise is asking for opening hours from 09.00am until 02.00am Monday to Saturday. However this closing time is the same for the performance of live music, recorded music, late night refreshment provision and supply of alcohol timings.

These hours are only from 09.00 am till 12.00 on Sundays.

This application is also asking for additional timings to these times listed to incorporate an additional hour on Bank Holiday 'weekends', Christmas Eve and Boxing Day the material timings being 10.00am - 03.00am. Also to allow 'Special timings on special event days' to allow any extension from 10.00 am to 03.00 am for 12 special events per year.

Recorded music, with or without DJ to include audience participation until these times.

Except New Years Eve and New Years day which specifies timings from 10.00 am - 23.00 hours continuous.

#### THE APPLICANT

The current applicant is not a personal licence holder and therefore although wishes to be the Designated Premises Supervisor at the premise, this cannot be granted until the applicant actually becomes a personal licence holder herself.

#### THE OPERATING SCHEDULE

Within the Operating Schedule (M - boxes A to E) the Act requires the applicant to describe any additional steps intended to be taken in order to promote all four licensing objectives namely: -

The prevention of crime and disorder Public safety The prevention of public nuisance The protection of children from harm

The steps detailed are adopted as conditions of the Premises Licence and arguably attempt to negate responsible authorities from making representations in respect of the application.

Having made an assessment of the schedule some of the conditions proposed are either not relevant, are catered for under other legislation, appear in duplicate or are clearly unenforceable.

South Wales Police are of the opinion therefore that the licensing objectives have not been adequately addressed.

Home Office guidelines issued under Section 182 of the Licensing Act 2003 and Bridgend County Borough Councils "Statement of Licensing Policy" allows representations to be amplified at hearings.

Licensing authority officers in their role as a responsible authority make the following representations:

- a. There is no wind down period of 30 minutes after the Sale of Alcohol has ceased, as to enable customers to finish their drinks in a timely manner prior to the premises closing, even though an extension to hours' is referred to in Section M (b) The Prevention of Crime and Disorder
- b. In the application under the premises description and shown on the premises plan, it is stated there is a rear outside area, there is no reference in the operating schedule to the management and supervision of the said area, as to prevent public nuisance, crime and disorder, public safety and protection of children from harm.
- c. It is stated in the application that alcohol will only be served with meals, it is impractical to suppose that patrons will be attending the premises up to 02:00 for the consumption of food and therefore suggest the end of alcohol consumption and late night refreshment ceases at 23:30.
- d. There is no reference to any CCTV operating within the licensed area
- e. Non-Standard timings state '12 other event days per annum at the applicant's discretion', no information is given on the type of events or if the Local Authority will be informed of such events.


