- 1. Purpose of Report.
- 1.1 On 1 September 2015, an application for a Review of the Premises Licence was submitted by the Chief Officer of Police in relation to the premises known as The Star Hotel, 144 Commercial Street, Maesteg, Bridgend.
- 2. Connection to Corporate Improvement Plan / Other Corporate Priority.
- 2.1 None.
- 3. Background.
- 3.1 A copy of the application form and background documents submitted by the Chief Officer of Police, together with a location plan is attached at Appendix A.
- 3.2 The Premises Licence Holder is Stephen Edward Hayes. A copy of the current Premises Licence will be available at the hearing. The Premises Licence authorises the following licensable activities between the below times:-

Supply of Alcohol:-

Monday to Saturday: 1200 - 0200 hours

Sunday: 1200 - 0000 hours

Christmas Eve and Christmas Day to 0200 hours

Live and Recorded Music:-

Monday to Saturday: 1900 - 0200 hours

Sunday: 1900 – 0000 hours

Christmas Eve and Christmas Day to 0200 hours

4. Current situation / proposal.

- 4.1 The application has been advertised in accordance with the regulations. A representation was received from the Trading Standards Department, a copy of which is attached at Appendix B.
- 4.2 At the time of preparing this report the Licensing Section were not aware of any discussions between the South Wales Police, Trading Standards Department and the Premises Licence Holder. An update will be provided to the Committee at the start of the hearing.

- 6.1 A full Equality Impact Assessment has not been undertaken in relation to this service, however due regard has been given to the implications on persons protected by equality legislation and human rights. 

THE PREMISE

The Star Hotel is a large terraced building which is situated in Commercial Street, Maesteg which is the main thoroughfare through the town centre and the dominant business area.

The premise no longer has the capability to facilitate residents and is a public house supplying alcohol and providing music.

The street comprises businesses, flats and bedsits and also contains a high concentration of licensed premises such as takeaways, restaurants, off-licences, public houses and a nightclub and therefore experiences a high volume of pedestrian and vehicular traffic.

Consequently within this area there is a disproportionate amount of crime recorded, in particular alcohol related violent crime, disorder, anti-social behaviour, public nuisance, litter and noise pollution as well as offences under the Licensing Act.

To corroborate these facts three licences in this street alone have been revoked, two recently, whilst a fourth was also forfeited at a venue located not too far away.

ENFORCEMENT BY THE RESPONSIBLE AUTHORITIES

Stephen Hayes became licence holder in **November 2010** however; on **15**th **December 2010** the Environmental Health Authority (EHA) was forced to serve upon him the first warning letter in respect of statutory nuisance from noise and amplified music.

Thereafter between **March 2011** and **November 2014** he has been subject of at least **13** other written warnings. Six have been issued by South Wales Police who have been made aware that a further seven have

been given by the EHA.

As the situation failed to improve the EHA was required to issue him with a Noise Abatement Notice in March 2011 and again in August 2012 whereupon he was instructed to submit an Action Plan within 14 days to include proposals as to how he would prevent breaches of the notice.

Additionally enforcement visits have taken place highlighting breaches of the licence which are the most serious offences and are contrary to Section 136 of the Licensing Act.

The warnings are notwithstanding the numerous incidents of crime and disorder which has resulted in calls to the South Wales Police Command & Control Room (CACR) at Police Headquarters, Bridgend via the 999 emergency or 101 non-emergency facilities.

The amount and nature of these calls seriously impacts on the licensing objectives.

Finally a meeting was held with Mr Hayes at Maesteg Police Station on 23rd January 2015 where he was addressed by Inspector Lewis, who had responsibility for the Maesteg Sector at the time, and Divisional Licensing Officers, Sergeant Williams and PC Ellis.

The situation at the premise was discussed with the licensee who was placed on an Action Plan in a final attempt to promote the objectives.

The plan is referred to elsewhere in the review however; since he signed it there have been incidents of: -

- Grievous Bodily Harm
- Other assaults
- Drunk & disorderly behaviour
- Public disorder
- Heavily intoxicated customers
- Staff failing to check youngsters for proof of age identification
- Children being allowed into the venue
- Contraventions of the conditions of the Premises Licence

Infact there have been an unacceptable number of incidents reported by the public both prior to and more significantly since the Action Plan was signed.

THE LICENCE

It is important that the Sub-Committee familiarise themselves with the licence which authorises the following activities:

Supply of alcohol Live Music Recorded Music **Making Music Dancing**

The sale of alcohol timings:

Monday to Saturday : 12.00 - 02.00 hours

Sunday: 12.00 - 00.00 hours

Christmas Eve and Christmas Day : 12.00 – 02.00 hours

Section 51 and 87

Regulated entertainment commences at 19.00 hours and ceases at the same time as alcohol sales end.

Opening hours of the premises:

As above plus 30 minutes winding down period

These are some of the longest opening hours for a public house within the county borough.

There are conditions attached at *Annex 1* and *3* whilst *Annex 2* concerns the proposals which are volunteered in applications by applicants which are then adopted as conditions i.e. conditions consistent with the Operating Schedule.

THE LICENSING OBJECTIVES

THE PREVENTION OF CRIME AND DISORDER

Alcohol related violent crime is prevalent where victims, assailants and witnesses have been intoxicated.

Numerous suspects have been brought into custody so drunk that custody staff have had to place them on intermittent observations to monitor their demeanour whilst many have not been able to receive their legal rights until a considerable period of time after arrest.

Other offences have taken place which are detailed elsewhere in the review whilst offences under the Licensing Act have also been committed which further fails to promote the objectives.

PUBLIC NUISANCE

The public nuisance objective is compromised as there have been several written warnings served by the Environmental Health Authority since **2010** as well as Noise Abatement Notices.

Enforcement resulted from excessive levels of amplified music and speech emanating from both inside and outside the venue.

PROTECTION OF CHIDREN FROM HARM

A number of incidents have involved minors with the most recent concerning an intoxicated female who was found at the premises along with her peers by her concerned father who escorted her home.

She was aged 14 years a mere four weeks earlier.

PUBLIC SAFETY

As indicated there have been a number of alcohol related disturbances and assaults which has resulted in injury, some serious, and the arrest of assailants.

One of the most recent incidents concerned a customer who sustained a double fracture of his jaw which required immediate attendance at hospital and corrective surgery involving the insertion of metal plates.

The victim was highly intoxicated and this appears to be a recurring theme with those who attend the venue.

BRIDGEND COUNTY BOROUGH COUNCIL'S "STATEMENT OF LICENSING POLICY"

Section 12 refers to REVIEWS OF LICENCES:

Sub-Section 12.1 "Reviews of Premises Licences represent a key protection for the community in respect of problems during the term of a Premises Licence."

HOME OFFICE GUIDANCE UNDER SECTION 182 OF THE ACT

Section 11 relates to REVIEWS: -

Sub-section 11.1 "The proceedings set out in the 2003 Act for reviewing Premises Licences represent a key protection for the community where problems associated with the licensing objectives occur after the grant or variation of a Premises Licence."

"REVIEWS ARISING IN CONNECTION WITH CRIME"

Offences have been committed under the Licensing Act 2003 and the Environmental Protection Act 1990.

Licensing guidance requires a clear emphasis on promoting the licensing objectives and is extremely specific to this application as it has been ignored.

CRIMINAL OFFENCES COMMITTED

THE LICENSING ACT 2003

Amongst other matters 5 of the 6 warnings issued by the police concerned contraventions of the licence i.e: -

1) Offence: Section 136

A) Carry on or attempt to carry on a licensable activity on or from any premise otherwise than under and in accordance with an authorisation i.e. a Premises Licence and the conditions which form part of it

OR

B) Knowingly allow a licensable activity to be so carried on.

The offences are considered so serious that the penalties are: -

- 1) An unlimited fine and/or a term of imprisonment on summary conviction not exceeding 6 months.
- 2) All alcohol and containers may be forfeited and destroyed.
- 3) The Premises Licence may be reviewed under Section 51.
- 4) Suspension or forfeiture of a Personal Licence.

THE ENVIRONMENTAL PROTECTION ACT 1990

1) Offence: Section 80(4)

Contravene or fail to comply with any requirement of an Abatement Notice.

Summary conviction: On business premises a fine not exceeding £20,000 together with a further fine of an amount equal to one tenth of that level for each day on which the offence continues after conviction

REVIEWS - GENERAL

A considerable number of premises within the borough have been subject of varied enforcement and licence holders have been given advice, received verbal and written warnings, and had meetings with South Wales Police which are designed to make management aware of police concerns to encourage them to address the problems being experienced in order to promote the objectives.

There have also been prosecutions resulting in offenders receiving substantial fines as well as having their Personal Licences suspended.

As a penultimate resort licence holders have been placed on an Action Plan.

Ultimately the review procedure has had to be utilised and numerous authorisations have been suspended and/or revoked.

South Wales Police feel that review is now the only appropriate form of enforcement,

DOCUMENTATION SERVED BY SOUTH WALES POLICE

Warning letters were served on: -

14th March 2011 24th May 2011 9th February 2012 2nd September 2013 24th December 2013 16th November 2014

5 were very clear and highlighted that the licence may be subject of the review procedure.

Additionally an Action Plan was given on 23rd January 2015.

DOCUMENTATION SERVED BY THE ENVIRONMENTAL HEALTH AUTHORITY

Through our sharing of information protocols South Wales Police have been made aware that written warnings were given on the following dates however; there may have been more letters served: -

15th December 2010 1st March 2011 23rd June 2011 6th January 2012 18th June 2012 2nd August 2012 16th January 2013

Similarly the warnings were also unambiguous highlighting that the licence may be subject of review.

Noise Abatement Notices were served on 1st March 2011 and 2nd August 2012 whereupon Mr Hayes was required to serve an Action Plan.

It is not known whether other partner agencies have similarly served warnings.

REVIEW RECOMMENDATIONS

As previously highlighted reviews represent a key protection for the community in respect of problems arising during the term of the authorisation.

Any decision made by the Sub-Committee must be taken following consideration of the representations received with a view to promoting the objectives.

The Sub-Committee may make a number of determinations which are highlighted within the guidance which will be reiterated in the Officers Report.

The disclosures in the application concern offences committed under the aforesaid acts which directly relate to the Licensing Act as the guidance in respect of criminality details that certain offences in particular should be treated very gravely and give rise for review.

Guidelines dictate that licensing authorities, the police and other law enforcement agencies will use the review procedures effectively to deter criminal activities.

However; it goes further and highlights that revocation of the licence, even in the first instance, should be seriously considered by Licensing Sub-Committees if it is determined that the premise is being used to further crimes which impacts on the crime prevention objective.

The most serious of offences have not only been committed under the Licensing Act but also the Environmental Protection Act and the latter offences fail to prevent public nuisance.

South Wales Police respectfully suggest that the situation will not change and feel that review is the only option now open which would address the failures outlined in the application.

Considerable enforcement and engagement with the licence holder has taken place which includes **13** warning letters, **2** Abatement Notices and **2** Action Plans however; the number of occurrences recorded, including those which give rise to serious concern, remains unacceptable.

Mr Hayes has therefore failed to promote all four objectives and as a consequence it is strongly recommended that the authorisation is revoked.

OFFENCES UNDER THE LICENSING ACT 2003

On Friday 4th March 2011 Ps 3705 McGill attended at the premise with Rebecca Thomas of the Public Protection Department in respect of the Noise Abatement Notice and warning letter served upon you on by Environmental Health.

Additionally information received by South Wales Police coupled with written complaints from the public indicates that persons under 18 years are attending at your venue and are being sold alcohol and that the venue is becoming problematic.

The sale of alcohol to a person under 18 years is contrary to Section 146 of the Licensing Act 2003.

The police and indeed the courts view the sale of alcohol to minors as particularly serious and in company with our partner agency Trading Standards the police regularly conduct test purchase operations involving child volunteers.

The premise will therefore be subject of any future operation.

Previous exercises involving the sale of alcohol to minors have resulted in not only significant fines but also suspension of Premises Licences.

The Licensing Sergeant reported that you were in denial of the allegations and of causing noise pollution and you should be aware that the Designated Premises Supervisor and Premises Licence Holder of another Maesteg premise adopted the same negative attitude.

The Community Safety Partnership in conjunction with the courts was recently forced to place a Notice of Closure on that venue under the Anti-Social Behaviour Act 2003.

A Section 51 Review application has since been served on the Licensing Authority and Premises Licence Holder recommending that the licence is revoked.

You should also familiarise yourself with the restricted conditions of the licence as numerous breaches of the conditions were evidenced during a targeted licensing visit in 2010 when pour landlord, was DPS.

Under Section 136 of the Licensing Act 2003 it is an offence to: -

A) Carry on or attempt to carry on a licensable activity on or from any premise otherwise than under and in accordance with an authorisation i.e. a Premises Licence and the conditions which form part of it

Or

B) Knowingly allow a licensable activity to be so carried on.

The penalties in respect of the above are considered so serious that the penalties are: -

- 1) A fine of up to £20,000 and/or a term of imprisonment on summary conviction not exceeding 6 months.
- 2) All alcohol and containers may be forfeited and destroyed.
- 3) The Premises Licence may be reviewed under Section 51.
- 4) Suspension or forfeiture of a Personal Licence.

I am also aware that you are the holder of a SIA licence and relevant licensing offences are categorised as "significant" under the Private Security Industry Act 2001.

A copy of this warning letter and documentation from Environmental Heath will be served on the SIA as per Police/SIA protocol.

If you are convicted of relevant offences under the Licensing Act 2003 the police will immediately disclose that conviction to the SIA and it is probable that they will revoke your SIA licence.

The courts may also revoke your Personal Licence.

I have now requested that local officers monitor the premise in order to ensure that you are complying with the Act and have forwarded a copy of this correspondence to Inspector Harris who is the Senior Officer responsible for policing the area.

If any further offences are committed in relation to the premises, under the provisions of the Licensing Act; this may result in you being prosecuted and/or have the Premises Licence reviewed.

Under Section 185 of the Licensing Act 2003 concerning the investigation of a complaint in respect of licensed premises a copy of this correspondence will also be disclosed to the Licensing Authority.

A further copy will be served on the Environmental Health Department.

You informed me that you are now licensed and awaiting the delivery of it. Can I remind you that if you act as SIA doorstaff you cannot physically perform another active role at that time.

OFFENCES UNDER THE LICENSING ACT 2003

At about 12.02am **Saturday 21st of December 2013**, a sixteen year old intoxicated female left your premises and some minutes later became the alleged victim of a crime on Commercial Street. This coincides with an observation made by patrolling officers that for a short period of time there were no door staff visible on the door and persons were entering without being checked for proof of age. The following is a breach of the restricted conditions of the Premises Licence: -

Offences committed by you as a Designated Premises Supervisor. (DPS): -

ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE: -

Protection of Children from Harm

All accompanied children to leave the premises by 1730hrs. If the premise operates past 0000hrs there will be a minimum of three staff on duty.

This is an offence contrary to Section 136.

Under Section 136 of the Licensing Act 2003 it is an offence to: -

A) Carry on or attempt to carry on a licensable activity on or from any premise otherwise than under and in accordance with an authorisation i.e. a Premises Licence and the conditions which form part of it

Or

B) Knowingly allow a licensable activity to be so carried on.

The offences in respect of the above are considered so serious that the penalties are: -

- 1) A fine of up to £20,000 and/or a term of imprisonment on summary conviction not exceeding 6 months.
- 2) All alcohol and containers may be forfeited and destroyed.
- 3) The Premises Licence may be reviewed under Section 51.
- 4) Suspension or forfeiture of a Personal Licence.

You have been warned about similar offences in the past which are all recorded and to have committed these again is unacceptable.

I have asked you to be more vigilant in the past and have asked you ensure your door staff challenge at every opportunity.

Under the provisions of the Licensing Act, I now have to consider you being prosecuted and/or have the Premises Licence reviewed. You assured me that these conditions would be met in future. You informed me that you are now licensed under the SIA and therefore fully aware of your responsibilities. Can I again also remind you that it is not good practice to act as both a door supervisor and a DPS?

During the early hours of **Sunday 9th November 2014** serious disorder occurred in Maesteg town centre and numerous officers were required to deal with the situation.

Seven individuals were arrested for violent disorder and investigation of the incident highlighted that those involved had attended at the Star Hotel and another venue immediately prior to the occurrence.

Upon arrest all offenders were highly intoxicated.

The sale of alcohol to a person who is drunk is contrary to Section 141 of the Licensing Act 2003.

You have an obligation to promote the licensing objectives at all times and should be mindful that your premise can be called in for review under Section 51 of the Act.

Infact South Wales Police has successfully applied to review the authorisations of three premises within Maesteg. The licences were revoked.

This letter may be regarded as official correspondence, which will be held on file and under Section 185 of the Act concerning the investigation of a complaint in respect of licensed premises a copy of this correspondence will also be disclosed to the Licensing Authority and Environmental Health.

On Behalf of Trading Standards, I wish to make representations to support the application of South Wales Police to review the premises licence for the premises known as "The Star Hotel" as detailed above.

This section shares the concern of the premises being able to achieve compliance, and feels that a review is an appropriate measure to use in achieving trading compliance and ensuring the community are protected from harm.

Of particular concern to Trading Standards is the reference to the presence of underage drinkers within the premises. This report is also corroborated by a further 2 complaints made to Trading Standards since January 2015, where similar complaints have been received from the public where it alleged that underage persons are drinking within the premises. Such activity is of great concern, and clearly has implications in meeting the objective of protecting children from harm.

Following the regular amount of warning letters, alongside an action plan implemented by South Wales Police, I agree and support that a licence review is the most appropriate measure available in dealing with these persistent breaches.
