

I am residential manager at Stoneleigh Court, a purpose built complex of 48 retirement apartments.

I wish to register my objection to the application for a premises licence at 104 John Street Porthcawl Butchers.

I shall relate my objection as requested under the licensing objectives.

1) Prevention of crime and disorder.

Residents and myself experience /witness antisocial behaviour from groups congregating in the bus shelters opposite and in the underpass leading to Station Hill. The easy access to alcohol opposite in the new butchers shop would encourage loitering and drinking and potentially further disorder/crime.

Local P.C.S.O.'s have visited Stoneleigh on occasions to ascertain details of damage to neighbouring commercial properties and other incidents .A new licence could result in further incidents requiring police presence.

2) Public Nuisance/Safety.

The hedges/trees opposite Stoneleigh are regularly used as a male urinal. The lane that runs from Victoria Avenue around the back of Stoneleigh and the butchers is used for drink, sexual activities and I have seen evidence of drug use. I regularly have to remove bottles and glasses from our gardens/car park. Broken glass on the pavement outside is a danger to pedestrians. I have escorted drunks from our site.

In my opinion there is a saturation of licences in our local area there would be a cummulative impact on nuisance should another licence be granted.

3) Protection of children from harm

There are significant numbers of children/teenagers who meet in the bus shelters,underpass and lane. Another shop selling alcohol would encourage their "dares" to obtain and drink alcohol.

Adults without conscience could purchase alcohol for children. Children could be put at risk of sexual, verbal and physical abuse.

Young people have cited limitations on alcohol availability to be a main driver for change in their generation.

Alcohol continues to be a leading risk factor for deaths for both male and females aged between 15 and 49 in the UK.




Our private front gardens already have empty bottles, cans, broken glass and other litter thrown over the wall and again this could increase.



Anti Social & Nuisance Problems



The premises front door is only about 20 feet from my apartment with a mere 2 feet between the proposed shop and my bedroom! All the apartments adjacent to the Porthcawl Buthcers Ltd will have a constant flow of people passing our windows with the ability to buy alcohol between the hours that have already been stated above. This will increase the possibility of intoxicated people being in the very near vicinity of the apartments, increasing noise and disruptive behaviour throughout the day and for the foreseeable future. By the very nature of this type of premises people will start parking on the road just to pop into the shop to make purchases. With the busy Porthcawl bus station opposite, this raises the risk of emergency services, especially ambulances gaining access to the apartments. Any delay could have a disastrous effect to the welfare of the residents. I have already found empty cans and other rubbish thrown into my front garden, another alcohol source very close by can only increase the problem. Over the last couple of months I have clearly heard the workmen from within my bedroom. If I can hear this noise then I will easily hear any increased noise from disruptive behaviour.

Crime and Public Disorder



ANTI SOCIAL - NUISANCE PROBLEMS


The applicants premises directly abut Stonleigh Court a retirement block of 50 apartments and where I live. The front shop door of the applicants premises is only approximatly 20 feet away from the bedroom window of the abutting ground floor apartments, the apartments taper back slightly but are all only a matter of feet away from the pavement. This means that all our apartments abutting Porthcawl Butchers Ltd will have a constant stream of people passing our windows and able to purchass intoxicants from 7.30am to 7.30pm weekdays and 9am to 5pm on sundays. By the very nature of this product there may be some customers who may be intoxicated or who have been consuming alcohol and there is every possibility of noise and disruptive behaviour from 7.30am to 7.30pm daily and forever more. There is also the aspect of the consumption of alcohol on the roadway outside Stonleigh Court and the congregation of drinkers in the bus shelter opposite.

lam 85 years of age and that is the average age of the residents. In some cases immediate ambulance attendance can be a life or death situation. Undoubtably customers using Porthcawl Butchers Ltd will use the outside of Stonleigh Court for short term parking while they "nip" into the off licence. this road is a one way street with

heavy traffic and 3 bus stops directly opposite and improperly parked vehicles always cause a complete stand still of traffic. We already experience problems in our pristine and well kept front gardens by "drinkers" who throw their empty cans over the garden railings, on occassions we have found bottles which appear to contain urine. There was one incident where a 2ft concrete pillar cap was pushed off into our gardens, and an added liquor source would only increase this dreadfull behaviour and could cause more distress to the elderly residents.

CRIME AND PUBLIC DISORDER

Directly opposite Porthcawl Butchers Ltd and Stonleigh Court is the porthcawl underpass, this is an area where "drinkers" congregate especialy during the wet and long winter evenings. It is quite an intimidating place to walk through when there are drunken groups of youths, both sexes rampaging there, our ladies will not walk through the underpass on their own and would rather take the longer walk around it. Adding another source of liquor supply would only increase the crime and disorder potential in the underpass and would probably require a more robust police presence thereby tying up police man power.







I refer to the above Application for a Premises Licence, submitted on 27th August 2015, and would like to convey my objections on the following grounds:-



- 2. The proposal would adversely affect the residential amenities of the occupiers of dwellings in close proximity to the site by virtue of increased anti-social behaviour with more noise and disturbance. Neighbouring Stoneleigh Court consists of fifty retirement apartments the residents of which would illicit no benefit whatsoever from such a provision thrust upon them on their doorstep. One can only imagine the degradation that will ensue with alcohol abuse yielding loutish, noisy behaviour not to mention vomit and urine mess. With so much alcohol provision readily available in Porthcawl, I would like to question what type of ambience we want for ourselves and the visitors to our town should this application be granted?
- I am aware that Porthcawl Butchers have submitted a Planning Application on this address which includes an awning. Should both the Planning and Licence Applications be granted then the awning would provide perfect shelter for groups to congregate and consume their recently purchased alcohol. The width of the pavement would force passers by into the road in this instance yielding further safety concerns.
- 4. Should a licence be granted, I, for one, would feel too vulnerable to leave my home should even a small group of customers decide to congregate outside the off-licence of an evening. Just leaving my apartment to enjoy a seafront walk on a Summer's evening would be too intimidating; certain unpleasant areas can always be avoided but when they are thrust right on your doorstep that is a completely different matter. I fear I would feel locked in my own home as I am sure many of my neighbours would.


