LICENSING ACT 2003: SECTION 17 APPLICATION FOR PREMISES LICENCE 35 MARKET STREET, BRIDGEND

1. Purpose of Report

1.1 This is an application made by Clyne Property Enterprises Limited for a new Premises Licence for an unnamed premises at 35 Market Street Bridgend. The premises consists of a ground floor and is described as a bar/nightclub in a town centre location.

2. Connection to Corporate Improvement Plan / Other Corporate Priority

2.1 None.

3. Background

- 3.1 A copy of the application form is attached at Appendix A together with the proposed licence plan.
- 3.2 The application is for a Premises Licence which authorises the supply of alcohol for consumption both on and off the premises. In addition, application is made for the licensable activities of regulated entertainment to include plays, films, indoor sporting events, boxing or wrestling entertainment and performance of dance. Live music has been amended from the original application to end at 0230 hours on all days of the week with the remaining hours for licensable activities (with late night refreshment commencing at 2300 hours) as follows:

Sunday to Thursday: 1200 to 0230 hours Friday: 1200 to 0400 hours Saturday: 1200 to 0500 hours

Live Music: Monday to Sunday: 1200 to 0230

Recorded Music to be played through a limiter with the sound levels being set and agreed with the Council: Sunday to Thursday: 1200 to 0300 hours Friday: 1200 to 0430 hours Saturday: 1200 to 0530 hours Hours open to the public: Sunday to Thursday: 1200 to 0300 hours Friday: 1200 to 0430 hours Saturday: 1200 to 0530 hours

The application includes non-standard timings for licensable activities as follows:

Sundays preceding a Bank Holiday/Christmas Eve/Boxing Day/New Year's Eve 1200 to 0500 hours (subject to the amendment relating to live music) and with a further period of 30 minutes during which the premises would remain open to the public.

The operating schedule setting out the steps the applicant intends to promote the licensing objectives is set out in Box M boxes a) to e) of the application form. Should the premises licence be granted, these measures would be translated into licence conditions subject to any amendments set out by the Responsible Authorities below.

3.3 The application has been advertised in accordance with Regulations.

4. Current situation / proposal.

- 4.1 Representations have been received from the Chief Officer of Police which are set out at Appendix B. All other representations have been agreed and the application is amended as follows:
 - All staff shall be trained in all aspects of the Licensing Act 2003 on the commencement of employment, then annually or more frequently if necessary. Signed records will be kept by the DPS and made available for inspection upon request by authorised officers and responsible authority officers.
 - 2) Challenge 25 will form part of the premises age verification policy, a copy of which will be made available for inspection upon request by authorised officers and responsible authority officers.
 - 3) Challenge 25 signage will be displayed prominently in all service areas.
 - 4) Live music to finish at 0000 hours.
 - 5) The installation of a noise limiter and the level to be set and agreed by this service.
 - 6) All live and recorded music to be played through the noise limiter.
- 4.2 At the time of preparing this report the representations from the South Wales Police had not been withdrawn.
- 4.3 The Sub-Committee must have regard to the Council's Statement of Licensing Policy and the Home Office Guidance issued under Section 182 of the Licensing Act 2003. However, the Sub-Committee must consider each application on its own merits having regard to the application, the operating schedule submitted and the representations made.

- 4.4 Sections 5, 6 and 9 of the Council's Statement of Licensing Policy are relevant to this application. Section 6 relates to a special policy in force in relation to the cumulative impact of premises in Bridgend Town Centre and specifically Market Street Bridgend where this premises is located.
 - "6.4 The effect of adopting a special policy of this kind is to create a rebuttable presumption that applications for new premises licences or club premises certificates or variations which are likely to add to the existing cumulative impact will normally be refused, if relevant representations to that effect are received, unless applicants can demonstrate in their operating schedule that there will be no negative cumulative impact on one or more of the licensing objectives. Whilst each case will be determined on its merits the term variation is taken to mean an increase in the hours during which licensable activities may take place, additional licensable activities, or an increase in the extent of the premises, insofar as these are likely to add to the negative cumulative impact.
 - 6.5 Applicants will need to address the special policy issues in their operating schedules in order to rebut the presumption, i.e. that the operation of the premises would not add to the negative cumulative impact experienced. The licensing authority will give proper regard to the different types of premises and the differing impact they will have on the local community. However, if no relevant representation is received, the licensing authority will grant the application in terms which are consistent with the operating schedule.
 - 6.6 This special policy will be kept under review and will not be used as grounds for revoking an existing licence or certificate.
 - 6.7 Notwithstanding the special policy, applicants are asked to note that each application will be dealt with on its merits. Following receipt of representations in respect of a new application in the above mentioned streets, the licensing authority will and must consider whether it would be justified in departing from its special policy in the light of the individual circumstances of the case."
- 4.5 Sections 2, 8, 9 and 10 and of the Home Office Guidance apply to this application.

5. Effect upon Policy Framework & Procedure Rules.

5.1 None

6. Equality Impact Assessment.

6.1 A full Equality Impact Assessment has not been undertaken in relation to this service, however due regard has been given to the implications on persons protected by equality legislation and human rights. Adverse impact of this Legislation on the equality protected groups is very unlikely. Consideration has been given to the guidance issued to accompany the Licensing Act 2003 relating to need to eliminate duplication and conflict with existing disability legislation and to reference and highlight the Council's Race Equality Scheme, polices and codes of conduct to applicants. We do not consider, on the basis of the above, that a detailed Equality Impact Assessment is required for this service. In line with our Inclusive Equalities Scheme we will monitor for any adverse impacts that may develop.

7. Financial Implications.

7.1 None

8. Recommendation.

- 8.1 The Sub-Committee is asked to determine the application having regard to the Council's Statement of Licensing Policy and the Guidance issued by the Home Office together with the representations made by the Police and other parties. The Sub-Committee is requested to have particular regard to the Cumulative Impact Policy in the decision making process.
- 8.2 The Sub-Committee is requested to confirm if the Licence is granted whether any additional conditions are to be imposed or only those which are consistent with and set out in the operating schedule. Section 10 of the Home Office Guidance relates to conditions attached to Premises Licences, Mandatory conditions will apply to the licence, if granted, in respect of the specification of a Designated Premises Supervisor, age verification policy and authorisation by personal licence holders.

a) General - all four licensing objectives (b, c, d and e) (please read guidance note 10)

The council's cumulative impact/special saturation policy impacts upon this application in that the premises falls within the relevant areas defined in the Special Policy adopted on the 12th November 2014. The applicant understands that the effect of the Special Policy is that there is a presumption against granting any application for a premises licence that is likely to add to the cumulative impact. The operating schedule which forms part of this application describes the measures which the **Papie**a2t will take to mitigate any such impact. The reasons why the applicant

contends that the application should be an exception to the policy are as follows:-1. The applicant will surrender its existing premises licence under which the premises has been traded in the past.

2. The applicant reasonably expects that in the main its clientele will be patrons who already use the Bridgend town centre late night economy and its facilities and in consequence there will be no increased cumulative impact as such persons are already in the area using the facilities in Bridgend town centre independently of the applicant premises.

3. The location of the premises is very close to one of the main town centre taxi ranks serving the Bridgend town centre and is close to and on the route of recognised drop off points for persons and parties attending the Bridgend town centre.

4. The applicant therefore considers that it is unlikely that this licence will add to the cumulative impact on the licensing objectives.

The premises will remain open for 30 minutes beyond the terminal hour for the provision of licensable activities to enable clientele at the premises to continue to use the toilet facilities and to leave the premises and the area in an orderly manner.

b) The prevention of crime and disorder

1. CCTV will be provided in the form of a recordable system capable of providing pictures of evidential quality in particular facial recognition. Cameras will encompass all access to and exits from the premises including fire exits and all areas, with the exception of toilets, to which the public have access. The equipment will be maintained in good working order. The system will continuously record whilst the premises is open for licensable activities and during all times when customers remain at the premises. Recordings will be timed and kept in date order for a period of 28 days and shall be handed to a police officer or local authority officer upon lawful demand. The designated premises supervisor will ensure that at all times a member of staff is on duty who is capable and competent to download CCTV recordings in a recordable format either to USB recorder or to disc, upon lawful demand by a police officer or local authority officer. The recording equipment will be kept in a secure environment under the control of the designated premises supervisor or another responsible named individual. An operational daily log will be maintained indicating that the system has been checked and is compliant. In the event of any failings of the system actions taken to rectify such failings will be recorded. If there is a technical failure of the CCTV equipment the designated premises supervisor will report such failure to the police.

2. Aside from off sales in sealed containers no glass wear or glass bottles will be taken outside the premises by patrons of the premises.

3. Door staff are to be employed at the premises. All such door staff will be SIA licensed door supervisors. Door staff will be employed at a ratio of one door supervisor per 100 premises customers who are on the premises.

4. A minimum of two SIA licensed door supervisors shall be on duty at all times when the premises is open for business.

5. A register of door supervisors will be maintained at all times at the premises. The register will include the name registration number contact details of the member of door staff along with a date time on duty and time off duty. Full details of any Page 22

agencies supplying door staff to the management of the premises will be endorsed on the register and the register will be available for inspection upon lawful request by a police officer or local authority officer.

6. Signs will be prominently displayed at the entrance to the premises and within the toilet facilities and at key strategic points within the premises to which the public have access, stating that drug use is unacceptable and that the venue operates a drug search policy as a condition of entry reserving the right to search customers under this provision.

7. The designated premises supervisor is to ensure that the premises actively participates in regular initiatives provided by South Wales Police to target drug misuse at the premises.

8. A drug safe will be present in the premises.

9. Either the designated premises supervisor or a manager appointed in his place will attend the Bridgend Pub and Club Watch Scheme meetings.

10. The premises is to participate in the night net radio communication scheme. Participation is to specifically include a member of staff responsible for signing on the system, monitoring responding to transmissions, making transmissions when incidents arise to alert other premises using the system and signing off. Such participation is to take place at all times when the premises is open to customers and trading.

11. The premises is to participate in all and any Bridgend town centre exclusion order schemes.

12. An incident book is to be maintained at all times to record any incidents of note at the premises and such incidents are to be recorded.

c) Public safety

1. The premises shall have an adequate system of counting persons in and out to ensure that customer levels in all areas of the premises do not exceed 400.

2. The number of customers permitted into the premises at any one time shall not exceed 400.

3. At least one suitably trained first aider shall be on duty when the premises is open to the public.

d) The prevention of public nuisance

1. Loud speakers shall not be located in the entrance lobby or outside the building of the premises.

2. Notices shall be prominently displayed at all exists requiring patrons to respect the needs of local people and to leave the area quietly.

3. Notices shall be prominently displayed at any area used for smoking requiring patrons to use the area quietly.

4. The designated premises supervisor shall ensure that any queue to enter the Page 23

premises which forms outside the premises is orderly and regularly supervised by door staff so as to ensure that the public highway is not obstructed and there is no public nuisance caused by such persons queuing to enter the premises.

e) The protection of children from harm

1. A challenge 21 proof of age scheme shall be operated at the premises where the only acceptable form of identification shall be identification which bears the photograph and date of birth of the holder together with an holographic mark of authenticity of such identification document.

2. A log shall be kept detailing all refused sales of alcohol. The log shall include the date and time of the refused sale and the name of the member of staff who refused the sale. The log shall be made available for inspection at the premises upon lawful request by a police officer or an officer of the local authority at all times while the premises are open for business.

3. The designated premises supervisor shall keep up to date records of staff training in respect of age related products and sales.

4. Other than for a specific youth event which has been agreed in writing beforehand with the police licensing officer no person under the age of 18 is to be permitted entry to the premises.

5. Notices shall be clearly displayed in the premises to emphasise to customers the prohibition on providing sales of alcohol or the provision of alcohol to any person under the age of 18 years.



The South Wales Police (SWP) refer to the above grant application and inform Bridgend County Borough Council Licensing Authority that there are police objections in respect to this application from the premises trading as 35 Market Street Bridgend, CF31 1LJ.

This application is made on behalf of Chief Superintendent Parfitt, the Chief Officer of Police who is of the view that the likely effect of the grant of this application on the licensing objectives would be an increase in Crime and Disorder, Public Safety, Public Nuisance and the Protection of Children from harm in the cumulative impact area of Bridgend.

Having regard to the information submitted in the Operating Schedule, South Wales Police are of the opinion that the operating schedule does not take into consideration the potential impact that extending the current operating hours will have on the licensing objectives and the potential to place an unequivocal demand on South wales police and other responsible authorities within this area.

THE PROPOSED HOURS

This application wishes to operate seven day a week with the closing times 03.00hrs Monday – Thursday 04.30hrs –Friday 05.30hrs –Saturday 03.00hrs - Sunday

For alcohol, late night refreshments, films, indoor sporting events, wrestling or boxing, plays, live music and recorded music being licenced until 05.00hrs.

South Wales Police feel the increase of the operating hours will not support any of the Licensing objectives and therefore will have a detrimental effect on the late night economy in the Bridgend Town Centre.

BACKGROUND TO THE LOCATION OF THE VENUE IN THE "SATURATION AREA"

The premises is situated in Market Street which is one of only 4 streets which form the "saturation area" which is subject of Bridgend County Borough Councils "Statement of licensing policy".

The area is saturated with licensed premises as it contains the highest concentration of public houses, nightclubs, restaurants, late night refreshment houses and takeaways anywhere in the borough and therefore experiences the highest volume of pedestrian and vehicular traffic and consequently the highest number of reported incidents.

There are continuous problems of crime and public disorder, anti-social behaviour, noise and public nuisance within the town centre on weekends and on BH weekends in particular.

Such incidents can be attributed to intoxicated individuals availing themselves of alcohol at venues which were operating until the very early hours.

Numerous alcohol related incidents are regularly recorded with violent crime in particular being prevalent.

There are significant increases in the level of reported occurrences from 2015 to present along with increases in reported offences which raises concerns of public safety. This is evidence in support of the need to implement steps to minimise any negative impact upon the saturation area.

Premises within this saturation area have been subject of various and prolonged enforcement over the years due to the failure of staff to promote public safety, protect children, prevent crime & disorder and prevent a public nuisance which are the key licensing objectives.

This area also contains residential properties and the quality of life of the residents needs to be taken into consideration when considering any application in this area, not only the residential properties within the saturation area but other neighbouring streets such as Quarella Road, Derwen Road and Coity Road will also be effected by noise nuisance.

SWP want to support any new business in Bridgend, however it must be run correctly, safely and within the remits of the Licensing Act 2003 and not have a detrimental effect to the general population who attend the Bridgend Town Centre and by objecting to the Licence SWP feel is a fair and proportionate way to help manage the cumulative impact area effectively.

Application

The closing time presently is in the early hours of the morning and the application is to extend the hours of licensable activity and opening on every day of its operating especially at the weekend.

The application does not say how this will not have a significant increase in Crime & Disorder at a time when the footfall in Bridgend town centre is at a high level at night and when the vast majority of incidents take place in the area.

South Wales Police object to the proposal on the grounds that crime and disorder would increase and Public nuisance will also increase and SWP feel this would be detrimental to the locality should this be granted.

The application makes reference to holding specific youth events at the premises with agreement from the Police, this will be aimed at an under 18 age group and raises significant cause for concern, SWP have had a significant increase in incidents in the Bridgend area when these events have taken place.

SWP have dealt with incidents during these events and Officers have located children drunk and in a confused state on the street, in a dishevelled state having clearly been vomiting unsure of where they are and on occasions with injuries, parents have had to be contacted and when no parent is available children not from the local area have had to be conveyed home as the duty of care now lay with the Police who had concerns for their safety.

The applicant has held youth charity events at the premises previously, initially without informing the Police and it is only by chance that the Police became involved, SWP informed Mr Rasul that if he ran the event he would be in breach of his License conditions and that SWP advised him his actions would be unlawful in regard to his License conditions. Mr Rasul remained adamant that the event would go ahead despite SWP concerns of placing Children in potential harm.

Police attended the event and identified further breaches of the License conditions as alcohol was clearly on display in this event.

It was further identified that there were very few adults present to look after the Children.

Incidents of intoxicated females have been previously reported at Berties Bar along with the report of large groups of youths fighting when a Youth birthday event took place and these incidents resulted in children being placed in a more vulnerable position.

SWP have today 26.4.2017 received a request via email from 35 Market Street that they wish to hold a Sixteenth Birthday party, this is a repeat of what has previously occurred and again there will be a breach of the Licence conditions and Mr Rasul will be aware of this.

The event will run from 6pm – 11pm which just supports the fact that they are prepared to place children in potential harm, Bridgend Town Centre at 11pm is no place for persons aged 16 years and possibly younger and even when described as a birthday party these events attract Children from out of the area.

The Police have again not been notified by the management of 35 Market Street but via Council Licensing Department which again is disappointing.

All below refer to incidents of violence at 35 Market Street and during the present operating hours. Although the premises was run by a number of other persons when this crime has occurred, it is quite likely to re-occur under new management.

The Premises

This application is quite unique as it is marketed as Eden Live lounge and Bar which is situated at 33 Market Street Bridgend next door to the Eden Bar and Grill which is situated at 35 Market Street and

primarily operating as a nightclub venue, these two venues are attached to each other in location as well as being owned and managed by the same family.

They share some of the facilities namely the same smoking area to the front of the premises and their customers would be the same who would freely attend either venue during the evening, moving freely from one venue to the other.

In effect this is one premise and the marketing suggests that this is one premise, although we have a situation where we have two separate licenses each containing different operating schedules for a premise which should clearly be covered by one premises license.

Eden Bar & Grill can accommodate numbers up to 500 person and Eden Lounge up to 400 persons so this now makes the venue one of the largest in the Town centre with a combined capacity of 900 persons and which will be one of the last premises to close which really must raise concerns.

With such a large venue the operating hours should be one that does not present any negative impact to this saturation area and which should benefit the Town Centre, however any increase in hours in relation to the current application would not be supported at this time as SWP cannot see how this will support the Licensing objectives.

APPLICANT

Mr Zahid Rasul will be the Designated Premises Supervisor of the venue and therefore have day to day control of the premises

The Premises has just been opened under the current management and therefore SWP have a small time frame to base their evidence on since its recent opening on the 30th April 2017, however incidents of Crime & Disorder were present at 35 Market Street even with the existing hours were in place.

With this in mind the Police have no other alternative and therefore feel it necessary to evidence the concerns they have had with the applicant Mr Rasul who is the Premises License holder of Eden bar & Grill which is situated next door to the application premise and managed by the same people.

As a direct result of the poor management of The Eden Bar & Grill there have been two lengthy meetings recently which the applicant was heavily involved in to identify and address the concerns of SWP have to the management of the premises.

A number of issues were identified by the Police and the management were invited to produce an action plan which would assist in making the necessary improvements to promote the Licensing objectives after a delay and a number of requests by SWP to the applicant the action plan was eventually submitted and the review period is still ongoing.

In the application for the License of the Eden Bar & Grill representations were made that the premises would be partly used as a restaurant and conditions put in place for this but time has passed and we have a situation where there is no restaurant or even a kitchen facility in place and the primary use of the premises is that of a late night bar and nightclub, it is apparent that no restaurant is going to be established at the location and SWP are concerned was this always the intention.

There has been a number of breaches of the License conditions which have been identified and due to the fact that SWP wished to work with the applicant it was agreed that there would be no formal

action regarding the identified Licensed breaches and so it was decided that a fresh start would commence where the management could now begin making improvements and this process has been a challenging period for SWP.

The applicant understands the saturation problems of the Town Centre and the effect of the Special Policy and what steps he will take to mitigate any such impact, however we need to fully understand that Zahid Rasul who is the Designated Premises Supervisor will be responsible for maintaining the Operating Schedule and we have strong concerns that this will not be done responsibly and we can evidence this by his strong involvement in the daily running of Eden at 33 Market Street Bridgend. **Eden Bar & Grill Conditions**

Annex 2 – Conditions Consistent with the Operating Schedule The prevention of crime and disorder:-

The Premises Licence Holder will ensure that the venue actively participates in the local Pub Watch or equivalent scheme.

There shall be no entry /re-entry to the premises after 0230 hours. The smoking area shall clost 30 minutes prior to closing.

Persons who have committed criminal offences will be detained until the arrival of the police

There shall be no entry/ re entry to the premises after 02.30 hours

The applicant or any of the management has not attended any Pub Watch meeting since 2016, persons who have been placed on the Pub Watch banned list have attended the Eden premise and have been involved in further incidents of disorder. (incident 1700070456) refers and this is a Breach of the Licensing conditions.

When Mr Zahid Rasul was recently approached by a member of Pub Watch he would not engage with them which raises concerns of how committed he really is to promoting the Licensing objectives.

There is further information which is subject to an ongoing investigation which can be provided in a closed season and which supports that the applicant was in breach of his Licensing conditions when dealing with a drug related incident (1700151831) refers, breach of Licensing conditions.

There has been a number of incidents of disorder which have gone unreported to Police and a male person who was the victim of an assault and suffered a fractured eye socket in the premises was not provided the right duty of care, incident (1700043558) refers.

In relation to the above incident there was no detention of the suspects at the time so no crime 'golden hour' principals were engaged. This is unfair that victims be penalised for whatever reason and does not support a partnership approach of working with the police and again in breach of the Licensed conditions.

There is Police evidence relating to persons entering the premises after 02.30hours which is in breach of the Licensing conditions incident (1700151831) refers.

Further incidents maybe referred upon at the hearing if reported after the time of this objection notice.

SWP have concerns that the conditions set out in the application may not be sufficient and will add to the existing saturation area and that these conditions may not even be adhered to and therefor will not support the Licensing objectives.

Revised Guidance issued under Section 182 of the Licensing Act 2003: March 2015 Representations from the police

9.12 In their role as a responsible authority, the police are an essential source of advice and information on the impact and potential impact of licensable activities, particularly on the crime and disorder objective. The police have a key role in managing the night-time economy and should have good working relationships with those operating in their local area. The police should be the licensing authority's main source of advice on matters relating to the promotion of the crime and disorder licensing objective, but may also be able to make relevant representations with regard to the other licensing objectives if they have evidence to support such representations made by the police unless the authority has evidence that to do so would not be appropriate for the promotion of the licensing objectives. However, it remains incumbent on the police to ensure that their representations can withstand the scrutiny to which they would be subject at a hearing.

South Wales Police cannot see how the existing application offered protects customers and supports the Licensing objectives.

At this current time, South Wales Police believes that an objection notice is a necessary and proportionate step in order to address the problems with this application and to advise that as it stands it should not be granted.

At approximately 0215hrs on Sunday 12 March 2017 I was on duty in police uniform, in company with PS4717 DAVIES, conducting a mobile patrol along Market Street, Bridgend in a marked police vehicle as part of Operation Raven.

Operation Raven is a late night economy Public Order and Public safety Operation that seeks to meet and greet members of the public into the late night economy in Bridgend and through early interventions and licensing strategies tries to prevent and deter more violent offences from occurring later in the evening.

At this time we were travelling past Eden Nightclub, Market Street, Bridgend when I saw a large group of people standing outside the entrance to the premise. PS4717 DAVIES and I decided to maintain observations on the entrance to the premise in order to monitor persons entering and leaving, and so I brought our marked police vehicle to a stop in the lay-by directly outside the club.

Upon alighting from our marked police vehicle I saw that there was a small cordoned smoking area located directly outside the entrance / exit which was not fit for purpose as it was full with only a handful of people. Others smoking were doing so amongst the door staff causing a general obstruction and creating a confusing environment for those door staff to work. It was nigh on impossible to distinguish between current customers and new arriving customers, and door staff were constantly having to look around and keep a check on those smoking and not giving their full attention to the security of the entrance / exit.

In general the system was shambolic, chaotic and unprofessional. It was also extremely unsafe for customers arriving and exiting.

The owner of the premises, a male person I know to be Zahid RASUL, then came out and spoke with PS4717 DAVIES, whereby PS4717 DAVIES informed him of the observations made by us and the concerns we had about the security of the entrance to his establishment and the safety of his customers.

At approximately 0250hrs on the same date PS4717 DAVIES and I decided to check other licensed premises within Bridgend Town Centre, and so drove away from Eden Nightclub, Market Street, Bridgend. Bridgend Town Centre was relatively quiet at this time and, with no issues seen or reported elsewhere, we decided to make our way back to Eden Nightclub, Market Street, Bridgend.

At 0300hrs on the same date I drove up Market Street, Bridgend and stopped just a few metres in front of Dragon Taxis office. At this time I had a clear and unobstructed view of the front entrance of Eden Nightclub, Market Street, Bridgend, and again saw a large group of people smoking and then re-entering the premise. I also saw new customers approaching along the street from both directions.

PS4717 DAVIES then brought my attention to a small group of people standing on York Place, Bridgend, alongside a building that once housed The York Tavern Public House and Munroe's Nightclub. These persons were watching us and it appeared to me that they were waiting for us to leave the area before trying enter Eden Nightclub.

I then drove towards Eden Nightclub, Market Street, Bridgend and again stopped our marked police vehicle in the lay-by located directly outside the premise.

PS4717 DAVIES and I alighted where I then saw and heard door staff informing people that entry and re-entry was now not allowed. It is my belief that this was only because our presence.

I then saw a male wearing a grey t-shirt with a distinctive 'ripped' pattern design on the upper arms and chest walk past me having come from the direction of Derwen Road, Bridgend. I saw this male approach the entrance to Eden Nightclub, Market Street, Bridgend from the pavement and attempt to gain entry. The male was stopped by door staff and informed that entry was now not allowed. The male then stepped back but remained at the location, walking towards the edge of the smoking area. I suspected that this male would make another attempt to gain entry and so I monitored his movements around the entrance and smoking area.

After a few minutes I saw the male walk behind door staff whilst they were distracted by persons smoking around them and enter the premise. He was not seen by door staff or Zahid RASUL, who was also present outside the club.

Upon seeing the male enter the club I immediately shouted to one of the door staff of what I had seen and then proceeded to walk into the entrance foyer myself in order to enter the club and assist with identifying and removing the male.

As I did so I heard Zahind RASUL stood in front of me and attempted to obstruct me from entering the premise. He said to me:

"You can't go into my club. I haven't given you my permission".

I informed RASUL that I did not need his permission as I had a power to enter any licensed premise and to step aside. I then moved passed RASUL and approached the doors that lead into the club.

Before I could open the doors however, Zahid RASUL rushed past me and placed his hands on both the door handles, preventing me from opening them and entering. RASUL then said to me:

"You are not allowed in my club. I have not given you permission. Do you have a warrant? You can't come in".

I informed RASUL again that I had a power to enter any licensed premise which was conferred to me under The Licensing Act, which meant that I did not need his permission or a warrant. RASUL continued to refuse to yield and so I informed him that if he did not move out of the way then he would be obstructing a police officer in the execution of their duty.

At this point a young Asian male who I do not know appeared at my right side and began shouting at me to "get out" and that I "was not allowed into the club".

I then warned RASUL that if he did not move out of the way he would be arrested for obstructing a police officer in the execution of their duty. At this point the doors were forced open from inside the club and I saw a male being escorted out by door staff. I then enter the club followed closely by Zahid RASUL and the young Asian male. I heard RASUL shouting:

"Get out of my club. Get him out of my club".

I then felt someone push me slightly from behind on my back but I did not see who it was. I turned around and saw Zahid RASUL and the young Asian male standing behind me and shouting at me to get out of the club. I then exited the club and saw that the male with grey t-shirt had been removed from inside.

Zahid RASUL and the young Asian male then stood around me and again were shouting at me with regard to my entering the club. I informed RASUL again of police powers in relation to licensed premises and that he risked arrest and prosecution should he obstruct officers in the execution of their duty. Eventually RASUL agreed and apologised to me and PS4717 DAVIES.

PS4717 DAVIES then explained to Zahid RASUL that we were gathering evidence regarding the operation of the premises and we have reported breaches of planning and licensing conditions. Zahid RASUL's reply to this was to begin to tell a story of mine and his first encounter and how the encounter was not to his satisfaction. Both me and PS4717 DAVIES informed RASUL that this story was irrelevant to the current situation.

PS4717 DAVIES then requested the assistance of other officers and shortly after PS4986 SULLIVAN and PC2398 WARREN attended, whereby we all completed a licensing visit of the premises. This was a full walk around of the premises including the toilets. We were escorted by a member of door staff that insisted on walking with us. At the end of the visit PS4717 DAVIES and PS4986 SULLIVAN were requested to sign a book titled 'DOORMAN' logbook to evidence our licensing visit. This book was not signed by any officer as there was no wording in relation to police visits on it.

No issues were found inside and we exited the club.

At 0400hrs on the same date PS4717 DAVIES, PS4986 SULLIVAN, PC2398 WARREN and I then left Market Street, Bridgend.

The following issues of concern were identified during our time outside the Eden Nightclub, Market Street,, Bridgend:

Poor management of current and arriving customers in a chaotic smoking area - unsafe and dangerous

Physically blocked and refused entry and resistance to allow an officer to enter when pointing out an entry after 0230hrs

Allowing entry to customers after 02:30hrs

I am Police Sergeant 4717 of the South Wales Police currently based on the Bridgend Neighbourhood Policing Team.

On Saturday 11th March 2017 I was on duty in full uniform in the Bridgend area covering Operation Raven in Bridgend town centre. I was in company with PC 2802 Chris Thomas.

Operation Raven is a late night economy Public Order and Public safety Operation that seeks to meet and greet members of the public into the late night economy in Bridgend and through early interventions and licensing strategies tries to prevent and deter more violent offences from occurring later in the evening.

At 02:15hrs I was conducting a mobile patrol of the town centre with PC Thomas. We parked the Police car outside Eden Night club to monitor customers entering and leaving the premises.

At this time I saw a large group of people standing outside the entrance to the premises. The cordoned off smoking area was full and there were people smoking in amongst the door staff causing a general obstruction and creating a confusing environment for the door staff to work, it was difficult to decipher between current customers and new arriving customers.

In general the system was working to a very low standard and myself and PC Thomas described it as a shambles and in chaos. The entrance policy could be hugely improved to separate and professionalise the process and create a safe area for arriving customers.

The owner of the premises Mr Rasul came out to speak to us and I told him my thoughts on the entrance to his establishment. He advised me of the potential solutions he had planned to alleviate this issue by the purchase of adjoining establishments.

Mr Rasul also told me that he had more door staff attending Eden that he was allowing into the premises. He stated that these males were not actually working there but were there as backup if they were needed. These males were not wearing any SIA badges. I would estimate that about 3 of these males arrived whilst we were present between 02:15hrs and 02:50hrs. One of these arrived after 02:30hrs and Mr Rasul explained their presence and role to me on their arrival.

We decided to leave Eden at 02:50hrs to drive around the town centre and check the rest of the licensed premises. As we were mobile and the town was fairly quiet we returned to Eden approx 03:00hrs. As we approached from the Radio cabs office end of Market Street I could see the front entrance to Eden was again a sea of people smoking and re entering the establishment with new customers approaching along the street from both directions.. There were people stood up by the old Munros building and it seems waiting for us to leave before trying to then enter Eden after our departure. The door staff were telling some people that the door was closed now and no further entry was allowed. I believe this was only because they had noticed our presence in the road.

I saw a male with a grey ripped t-shirt (part of the design rather than damaged) has approached the door from along the pavement. We have decided to monitor his movements around the entrance. After a short while he has managed to gain entry and this has been noticed by PC Thomas.

This entry has been pointed out to door staff and PC Thomas has entered the main door. I followed shortly afterwards. PC Thomas was then STOPPED by Mr Rasul at the entrance and refused entry by holding the doors closed. Mr Rasul has blocked his progress into the club. PC Thomas protested to me that he had been stopped by Mr Rasul from entering the premises.

Pc Thomas has stated that he has power to enter licensed premises and that he is causing him to be obstructed in his duty. PC Thomas explained that he would be arrested if he didn't move out of the way. The male with the grey t-shirt was located and removed by door staff through the door. As Pc Thomas entered the premises Mr Rasul was shouting for him to get out. "Get him (PC Thomas) out of my club"

A tense discussion then took place between officers, Mr Rasul and another young Asian male in the foyer area of the club. Mr Rasul was advised about Police powers and that he risked arrest if he caused an obstruction to officers. He then agreed and apologised. I explained to Mr Rasul that we were gathering evidence regarding the operation of the premises and we have reported breaches of Planning / licensing conditions.

I have pointed out to Mr Rasul again that the smoking area is chaos and there is little control over who is a customer and new arrivals. It becomes confusing for door staff.

Instead of listening to our feedback Mr Rasul has taken the opportunity to tell a story of PC Thomas and his first encounter with him and how the encounter was not to his satisfaction. I advised Mr Rasul that this story was irrelevant to the current situation and PC Thomas is the NBM for the town centre and enforces the law correctly.

I called for further officers to attend to assist and extended our tour of duty.

On arrival of PS Sullivan and PC Warren, myself and PC Thomas all completed a licensing visit of the premises. This was a full walk around of the premises including the toilets. We were escorted by a member of door staff that insisted on walking where we walked. At the end of the visit I was requested to sign a book titled DOORMAN logbook to evidence our licensing visit. However there was not specific wording relating to the Police visit so nothing was signed.

Nothing untoward was found and officers returned to the outside of the door. Further discussions with Mr Rasul were done but these were generally repeating previous conversations.

Officers then left after 4am and returned to station.



0300HRS AS A REQUEST FROM PS 4717 DAVIES WHO HAD STAYED ON WITH PC 2802 THOMAS MYSELF AND A/PS TOM WARREN (WHO ALSO HAD TO STAY ON) ATTENDED TO BACK THEM UP.

LARGE CROWD IN SMOKING AREA, WAY TO MUCH TO BE HANDLED EFFICIENTLY. I ASKED CCTV TO MONITOR THE FRONT TO GAIN EVIDENCE SO IT SHOULD ALL BE ON THERE BUT HE INSISTS IN PARKING HIS BLUE VAN IN THE TAXI BAY TO TRY AND OBSCURE THE FRONT DOOR
