1. Purpose of report

- 1.1 The purpose of this report is to determine an application for a premises licence submitted by Gilfach Goch Community Welfare Hub for the Pavilion, Welfare Park, Evanstown, Gilfach Goch.
- 2. Connection to corporate well-being objectives / other corporate priorities
- 2.1 This report relates to a regulatory function and as such has no link to the corporate objectives.

3. Background

- 3.1 A copy of the application form is attached at Appendix A together with the proposed licence plan.
- 3.2 The application is for a Premises Licence which authorises the various licensable activities at the premises: Sale of alcohol, live music and recorded music.
- 3.3 The timings requested are as follows:

Supply of Alcohol: Monday to Sunday 1200 to 2300 hours On the premises only No non standard timings

Live and Recorded Music: Monday to Sunday: 0800 to 2330 hours Indoors only No non standard timings

- 3.4 The operating schedule setting out the steps the applicant intends to promote the licensing objectives is set out in Section M boxes a) to e) of the application form. Should the premises licence be granted, these measures would be translated into licence conditions.
- 3.5 Relevant representations have been received from residents copies of which are set out at Appendices B to I. Personal data has been removed from the

representations. Matters outside the remit of the licensing authority have also been redacted.

The application was considered by the Responsible Authorities and no other representations have been received.

Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

A copy of the Crime & Disorder Prevention Policy will be kept at the premises at all times. Well trained staff will contribute to a well run premises, with staff having a clear understanding of the responsibility which comes with the Sale of Alcohol and late night refreshments. All staff will be fully trained on the Licensing Laws surrounding the Sale of Alcohol and detailed records of this training will be kept and updated on a regular basis. All records will be securely stored on premises and available for inspection at anytime.

b) The prevention of crime and disorder

The Premises has an Alarm which will secure the property when closed. Officals & staff of the Hub will be vigilant of ejecting or refusing entry if a person(s) are known to be aggressive or violent. Staff will be trained to preserve a crime scene until police arrive should an outbreak of disorder happen. Challenge 25 notices will be clearly erected and staff will maintain this procedure at all times. A zero tolerance policy to the use of Drugs and carrying Weapons on the premises will be implemented, with both officals and staff notifying the police immediately if suspected. Sufficient staff will be made available at the close of business to manage a controlled shut down of the premises and maintain good order when customers leave. Outdoor lighting will be erected and CCTV cameras both exterior and interior will be installed with a recording system.

c) Public safety

A first aid box will be available on the premises with sufficient stock. There is a defibrillator sited on the outside of the building and one will be located indoors. Temperature levels will be monitored regularly for the comfort and safety of customers. Regular glass collections to prevent obstruction to customers and stop glassware being transferred to external areas. Signage and notices of any hazards such as wet floor will be available and implemented if an incident occurs. The building has a fully operational fire detection system which will be regularly monitored and serviced by professionals. Emergency Exits are clearly visable and accessible so a clear route to safety can be maintained if an incident occurs. An accident book will be located on site to record all accidents or incidents.

d) The prevention of public nuisance

Noise management will be in place to prevent music, singing & speech noise breaking out from premises. All windows and doors will be kept closed whilst premises licence is in operation. Adequate staffing levels will be maintained at end of business to control customers and maintain good order as customers leave. Notices will be erected at the entrance/exit "Please Respect our Neighbours – Leave Quietly" and regularly announcements will also be made by staff notifying patrons of this. Regular patrols of the external area will be made to clear any litter attributable from the premises. When the building is closed external lighting will be reduced and notification notices of CCTV in operation will be clearly visable.

e) The protection of children from harm

A documented child protection policy to protect children from harm will be in place at all times. Children will be restricted access to the building depending on the function being held at the premises, however the general access for children will be up to 8pm, following this a child must be accompanied by a responsible adult. A strict "No ID — No sale policy" for alcohol will be operational and staff will be fully vigilant of preventing under-age drinking. Signage will be prominent at the premises notifying customers "It's an Offence to Purchase Alcohol on behalf of an under-age person. A strict policy of omitting anyone who does not adhere to rules will be in place and fully implemented.

I have just found out today that again an application for a license for Drinks has been applied for

I am aware that the various sports groups have applied for an application to extend the existing sports building situated within the park to be extended into a local hub for various uses this I have no objection to at all. My objection is the right to apply for this to be used as licensed premises to sell alcohol.

I cannot understand with whatever changes that have been proposed by a community hub that this would include any alterations to allow a licensed premises to sell alcohol.

The proximity of the children's play area and the ability to allow children to play, grow and have the enjoyment of the local park as a safe haven is still the same a previous and remains unchanged. Children should be allowed to use the park at any time of the day or evening without being subject to being left open to what could be considered to be a vastly changed environment if a license is granted. How can any fence or lighting provide children with safety from a number of items.

- 1. How can any licensed premises ensure that glassware and bottles would not enter this location. This could lead to broken glass or bottles right next or in very close proximity to playing children. The risk In Any risk assessment would be greatly increased.
- 2. How can a fence provide a suitable screen from children playing in a park from the building users under the influence of alcohol. No licensee can assure the local authorities against the the inappropriate behaviour of its users from drinking (language and anti social behaviour from its users once alcohol has or would be served) this does not give small children or indeed teenage children the best experience of using a children's play area or sports area. Surely the two can't be mixed.
- 3. What assurances can any social hub that serves alcohol give to the local residents and its children that no harm would come to them once they are out playing and having the fun experience that they have received for the many years that children have played within the park as it is at present.
- 4. Again surely there is a massive difference to the use of the park once a license has been granted. It would not be safe to allow mid range children say 10 and onwards to be left unattended by parents as they can today. Users that are this close to children playing under the influence will give the wrong impression to these children. Who indeed are very use to impress and thus shouldn't be any impression that any local authority should even consider.
- 5. Presently parents can allow their children to play any time of the day 7 days a week without the worry they would have once a license would be granted.

I feel that parents, grandparents and family members would restrict children's use of the parks facilities without an adult being present with them at all times and even with an adult the possibility of anti social behaviour would not be acceptable and children's time to play and enjoy would be great encroached upon.

I as one resident would object to the granting of the said license.


