### 274. APPLICATION TO LICENCE HACKNEY CARRIAGE VEHICLE

The Team Manager (Licensing) presented a report, the purpose of which, was to ask the Sub-Committee to consider an application to grant a licence for a hackney carriage vehicle.

She explained that an application had been submitted by Peyton Travel Limited of Bridgend, to licence a Dacia Logan Stepway vehicle registration number WP86 LVD as a hackney carriage vehicle to seat 4 persons.

The vehicle was pre-owned and first registered at the DVLA on 11 January 2019.

The Team Manager (Licensing) proceeded, by advising that the application falls outside the Hackney Carriage Vehicle Policy approved by the Licensing Committee. The vehicle was not wheelchair accessible. A service report had been submitted for 14 February 2020, with the mileage received at 12,301.

On the 3 November 2020 an Enforcement Officer inspected the vehicle and the vehicle was found to be in good condition. A Vehicle Assessment Form was provided at Appendix A to the report. At the time of inspection the mileage was recorded at 19,187.

The application fell outside the provisions of the Council's Licensing Policy, for the reasons detailed in paragraph 4.5 of the report.

RESOLVED: The Sub-Committee considered the application to register

WP86 LVD as a hackney carriage vehicle to seat 4

persons.

Members noted that it fell outside of policy 2.1 of the Council's Licensing Policy, for the reasons outlined in the report.
