Executive Summary:	For the Sub-Committee to consider and determine an application submitted by South Wales Police to review the premises licence at Eden, 33 Market Street, Bridgend, CF31 1LJ under Section 51 of the Licensing Act 2003

1. Purpose of Report

1.1 The purpose of this report is to determine an application received from South Wales Police to review the premises licence in force for the premises known as Eden, 33 Market Street, Bridgend, CF31 1LJ.

2. Background

- 2.1 The Licensing Authority has received an application to review the premises licence which is attached at *Appendix A and attachments A1 to 5.* South Wales Police are a responsible authority for the purposes of this application.
- 2.2 The premises licence BCBCLP740 is jointly held by Zahid and Saima Rasul and a copy is attached at *Appendix B* to this report. Saima Rasul is the Designated Premises Supervisor.

3. Current situation/proposal

- 3.1 In accordance with the requirements of the Licensing Act 2003, the application was served on the premises licence holders and copies of the application were forwarded to the Responsible Authorities.
- 3.2 During the statutory 28-day consultation period the application has been advertised in accordance with the regulations and no representations were received.
- 3.3 Section 51 of the Licensing Act 2003 provides that where a premises licence has effect, a responsible authority or any other person may apply to the relevant licensing authority for a review of the licence. This must relate to a concern arising at the premises in connection with any of the four licensing objectives. The application

states that the application relates to the licensing objectives of the prevention of crime and disorder and public safety. The application summarises that the premises licence holders have failed to provide CCTV footage to South Wales Police as required by a condition of the premises licence.

- 3.4 Before determining the application, the authority must hold a hearing to consider it and any relevant representations received.
- 3.5 The authority must, having regard to the application and any relevant representations, take such of the steps mentioned in subsection (4) (if any) as it considers appropriate for the promotion of the licensing objectives.
- 3.6 The steps in subsection (4) of Section 51 are:
 - (a) to modify the conditions of the licence;
 - (b) to exclude a licensable activity from the scope of the licence;
 - (c) to remove the designated premises supervisor;
 - (d) to suspend the licence for a period not exceeding three months;
 - (e) to revoke the licence; and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.
- 3.7 Equally, the licensing authority may decide that the review does not require it to take any further steps appropriate to promoting the licensing objectives.
- 3.8 The Licensing Act 2003 (Section 4) states that it is the duty of all Licensing Authorities to carry out their functions under the Act with a view to promoting the licensing objectives. The licensing objectives are:
 - a) The prevention of crime and disorder
 - b) Public safety
 - c) The prevention of public nuisance
 - d) Protection of children from harm

Each objective is of equal importance and should be of paramount consideration at all times.

- 3.9 Section 4(3) Licensing Act 2003 states that the Licensing Authority should also have regard to the Council's Statement of Licensing Policy, the Statutory guidance issued under Section 182 of the Licensing Act 2003 and the Licensing Act itself, in this case in particular to:
 - a) Paragraphs 5,11 and 12 of the 2019-2024 Statement of licensing policy
 - b) Chapters 2, 11, 13 and 14 of the Statutory guidance, as revised August 2023
 - c) Sections 51 to 53, 182 and 183 of the Licensing Act 2003.
- 3.10 It is likely that the parties involved will be providing additional evidence as permitted under the Licensing Act 2003 (Hearings) Regulations 2005. Regulation 18 permits that in considering any representations or notice made by a party the authority may take into account documentary or other information produced by a party in support of their application, representations or notice (as applicable) either before the hearing

or, with the consent of all the other parties, at the hearing. This will be confirmed at the start of the meeting.

4. Equality implications (including Socio-economic Duty and Welsh Language)

Please state the ground(s) for review (please read guidance note 1) On Friday 17th February 2023 a warning letter was hand delivered to Zahid and Saima Rasul at Eden, 33 Market Street, Bridgend. The letter was compiled on 16th February 2023 after a number of failers by the Premises Licence Holders in producing CCTV to authorised officers, as per a requirement of their premises licence. The licence states:

1) CCTV will be provided in the form of a recordable system capable of provding pictures of evidential quality in particular facial recognition. Cameras will encompass all access to and exits from the premises including fire exits and all areas, with the exception of toilets, to which the public have access. The equipment will be maintained in good working order. The system will continuously record whilst the premises is open for licensable activities and during all times when customers remain at the premises. Recordings will be timed and kept in date for a period of 28 days and will be handed to a police officer or local authority officer upon lawful demand. The designated premises supervisor will ensure at all times a member of staff is on duty and capable to download CCTV recordings in a recordable format either to USB or to disc, upon lawful demand by a police officer or local authority officer. The recording equipment will be kept in a secure environment under the control of the DPS or another responsible named individual. An operational daily log will be maintained indicating that the system has been checked and is compliant. In the event of any failings of the system actions taken to rectify such failings will be recorded. If there is any technical failure of the CCTV equipment the DPS will report such a failure to the police.

Please provide as much information as possible to support the application (please read guidance note 2)

Since the 8th May 2023 there have been three separate incidents where Zahid and Saima Rasul have failed to provide CCTV to authorised officers. Persons involved in these incidents have been bailed pending further investigation, failure to provide CCTV has a huge detramental effect on the investigation of such crimes and the persons involved, along with a huge amount of officer time wasted by continually trying to obtain CCTV footage.

I have not received the CCTV from Eden and I have sent a second email requesting this. The manager stated he would bring it to Bridgend Police Station but there has been no USB drive brought to the station.

Eden are not open until the weekend. I am not covering the weekend on this working set however I shall make arrangements to collect this footage on my next set.

24/07/2023 21:32 - DC 5735 Perkins I have received an email from the manager of Eden regarding the CCTV. He has stated he has been away on holiday and will provide the CCTV requested however I have not had any response since. The email address and name is -

and asked why the CCTV has not yet I have spoken to Mr Rasul on been furnished - he informed me that he was expecting an officer to be at the club premises on Saturday 22nd July. I have stipulated that the wait is unacceptable and he is once again frustrating South Wales police investigation's which in turn is having a detrimental impact on those people involved in the investigation.

He has advised he will send the CCTV via NICE today - I have emailed DS Amy Baker and advised her of this. I have requested an officer make contact with him and arrange for the link to be sent as a matter of priority as the CCTV will be lost after 28 days which is 3 days away.

I have made a number of attempts to contact Bobby by phone/ text and have also attended Edens to explain the evidential difficulties, however when Bobby tells me he will get back to me he never does

Having reviewed the evidence available, we currently have a complaint, however there is no witness to actually identify the suspect. The recording equipment will be kept in a secure environment under the control of the DPS or another responsible named individual. An operational daily log will be maintained indicating that the system has been checked and is compliant. In the event of any failings of the system actions taken to rectify such failings will be recorded. If there is any technical failure of the CCTV equipment the DPS will report such a failure to the police'.

South Wales Police take all reports of assault extremely seriously, CCTV footage is paramount to investigating such incidents. Please ensure compliance of the above condition and produce CCTV as soon as practicably possible in order for officers to throughly investigate such allegations.

Up until Wednesday 8th February it had been noted that there was no representative from the premises attending the local Pubwatch meetings. Please ensure a representative attends meetings as per your licence conditions.

On 21st January 2023 a male was arrested outside Eden and charged with a public order offence, the male was seen on CCTV to leave Eden prior to the offence. 

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

(d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner; (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

The premises licence holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The recording equipment will be kept in a secure environment under the control of the DPS or another responsible named individual. An operational daily log will be maintained indicating that the system has been checked and is compliant. In the event of any failings of the system actions taken to rectify such failings will be recorded. If there is any technical failure of the CCTV equipment the DPS will report such a failure to the police.

2) Aside from off sales in sealed containers no glassware or glass bottles will be taken outside the premises by patrons.

3) Door staff will be employed at a ratio of one door supervisor per 100 premises customers who are on the premises.

4) A minimum of 2 SIA licensed door supervisors will be on duty at all times when the premises is open for business.

5) A register of door supervisors will be maintained at all times at the premises. The register will include the name, registration number and contact details of the member of door staff along with a date and time for on and off duty. Full details of any agencies supplying door staff to the management of the premises will be endorsed on the register and the register will be available for inspection upon lawful request by a police officer or local authority officer.

6) Signs will be displayed at the entrance to the premises and within the toilet facilities and at key strategic points within the premises to which the public have access, stating that drug use is unacceptable and that the venue offers a drug search policy as a condition of entry and reserve the right to search customers under this provision.

7) The DPS is to ensure that the premises actively participates in regular initiatives provided by South Wales Police to target drug misuse at the premises.

8) A drug safe place will be present in the premises.

1) A Challenge 21 proof of age scheme will be operated at the premises where the only acceptable form of identification will be identification which bears the photograph and date of birth of the holder together with a holographic mark of authenticity of such identification document.

2) A refusal log will be kept at the premises. The log will include the date and time of the refusal and the name of the member of the staff who refused the sale. The log will be made available for inspection at the premises upon lawful request by a police officer or officer of the local authority at all times the premises is open for business.

3) The DPS will keep up to date records of staff training in respect of age related products and sales.

4) Other than for a specific youth event which has been agreed beforehand with the police licensing officer no person under the age of 18 is to be permitted entry to the premises.

5) Notices will be clearly displayed at the premises to emphasise to customers the prohibition of sales of alcohol to any person under the age of 18 years.
