	<p>The presentation detailed Halo Leisure's wellbeing programmes offered to the local communities across their facilities, including their Access to Leisure scheme, their Feel Good for Life programme offering dementia-friendly activities to support older adults with dementia, loneliness and depression and autism-friendly swimming lessons for young people living with ASD or intensive needs.</p> <p>Following Mr Rolfe's submission, the Mayor opened up questions, examples of which were as follows:</p> <ul style="list-style-type: none"><li>• Commitments and plans to support assets held by Halo as a custodian going into the future.</li><li>• Potential reductions in take-up due to transport costs or other associated factors.</li><li>• Visions for the future.</li><li>• Estimates for remedial work to leisure centres within the County Borough.</li><li>• An explanation regarding ways that Halo Leisure can further encourage access to facilities for high-level athletes.</li><li>• Any plans to expand provision or facilities to cover a wider range of activities.</li><li>• Potential plans to move to an agency model.</li><li>• Whether additional Town and Community Councils can participate and support schemes offered by Halo.</li><li>• Collaboration possibilities with the Bridgend Youth Service.</li><li>• How anti-social behaviour around Halo centre's is treated.</li></ul> <p>The questions and queries raised above (as well as others) that Mr Rolfe could not sufficiently respond to, he confirmed that he would follow-up and respond to outside of the meeting.</p> <p><u>RESOLVED:</u> That Council noted the presentation as referred to at paragraph 3.1 of the report.</p>

**229. Children's Residential Home**

Decision Made	<p>The purpose of this report, presented by the Deputy Leader and Cabinet Member for Social Services, Health and Wellbeing, was to seek Council approval for the inclusion of a capital budget of £1,620,450 in the Capital Programme for the proposed acquisition and refurbishment of a residential home to be registered with Care Inspectorate Wales (CIW) as a children's residential care home.</p> <p>Members posed questions on:</p> <ul style="list-style-type: none"><li>• Whether other suitable land could be used for the same purpose as the proposed property acquisition.</li><li>• Whether BCBC can claim relief on this property similar to other social landlords.</li><li>• Whether BCBC can mitigate any potential roadblocks to obtaining the funding.</li><li>• The reasoning behind this report coming before Council without first going through the Scrutiny process.</li><li>• The proposed property's price to acquire.</li><li>• Possible alternatives to better use the allocated funds.</li><li>• The possible creation of a set of rules and guidance around future similar investments so that a precedent can be established to have more details on any schemes such as this proposed in the future.</li><li>• Whether other buyers may attempt to purchase the property earmarked for the spend.</li><li>• The logic behind the quoted refurbishment price.</li></ul>

- c. Authorised the Corporate Director - Communities and Group Manager - Planning and Development Services to make minor presentational changes, typographical or factual corrections as necessary prior to publication of the adopted Outdoor Recreation Facilities SPG.
- d. Authorised the Corporate Director – Communities and Group Manager – Planning and Development Services to update, as necessary, the web links to external best practice guidance documents listed under the 'Design Guidance by Outdoor Recreation Facility Typology' heading in Section 7.0 of the Outdoor Recreation Facilities SPG, to ensure they remain current and accurate.
- e. Authorised the Corporate Director – Communities and Group Manager – Planning and Development Services to update the costs set out in Table 1 (page 11), Appendix A and Appendix B of the Outdoor Recreation Facilities SPG periodically to ensure such costs remain up-to-date and reflective of current costs.
