SERVICE AND PERFORMANCE UPDATES

1. Purpose of Report

- 1.1 The purpose of this report is to update the Democratic Services Committee on the performance of services provided to Elected Members.

- 4.4 Town & Community Council (TCC) Website Grants
- 4.4.1 Democratic Services is currently facilitating the administration of a Welsh Government Grant to provide £500 to each TCC within the County Borough to develop their web presence.
- 4.4.2 To date, 17 of the 20 TCCs have completed the grant agreement and have submitted claims which have been paid.
- 4.4.3 The closing date for applications for this grant was 31 March 2015 but the Welsh Government has agreed that the deadline can be extended and all efforts are being made to encourage Town and Community Councils to submit appropriate grant applications.

4.6 Members ICT Forum

- 4.6.1 At its last meeting the Members ICT Forum considered the Members ICT survey which requested Members views on how they used ICT equipment and what facilities and functionality would be beneficial to be provided after the 2017 Local Government Elections. The Group Manager ICT is now looking at possible options to meet the identified requirements and to prepare for a pilot of the proposed options.
- 4.7 Town & Community Council Charter
- 4.7.1 The Town and Community Council Charter was signed by BCBC and all 20 Town and Community Councils on 18 July 2016. The BCBC website has been updated to reflect the revision of the Charter.
- 4.7.2 The first quarterly meeting of officers with the Town and Community Clerks was held in August which was very useful and attendees welcomed the potential benefits that these meetings could bring.
- 4.8 I-Call
- 4.8.1 I-Call is a check call management system designed to monitor and provide reassurance to people working alone. This has been previously discussed but due to the costs of the system and the need to use BCBC provided mobile telephone this facility has not been offered to Elected Members.

- 4.8.2 Although there will be some initial limitations on the use of the I-Call system, it has been agreed that a trial of the system with Elected Members can be undertaken. The trial will provide an opportunity to ensure that those members who may feel vulnerable when visiting constituents are able to be supported by the Authority. If the trial is successful it will be made available to all Members.
- 4.8.3 One member volunteer has already agreed to participate in the trail and it is hoped that a further 2 members would be willing to become involved. Members of the Democratic Services Committee willing to volunteer for the I-Call trial are requested to inform the Head of Democratic Services at the earliest opportunity. This opportunity will be offered to all members in due course.
