REPORT OF THE CORPORATE DIRECTOR OPERATIONAL AND PARTNERSHIP SERVICES

INITIAL OUTCOMES - POTENTIAL CANDIDATE EVENTS

- 1. Purpose of Report.
- 1.1 The purpose of this report is inform the Democratic Services Committee of the initial outcomes from the 'Potential Candidate' events held on 11 and 12 October 2016, for anyone considering standing as a Bridgend County Borough Council Councillor at the Local Government Elections in 2017.
- 2. Connection to Corporate Plan / Other Corporate Priority.
- 2.1 The support to be provided to Elected Members assists in the achievement of all of the following corporate priorities:
 - 1. **Supporting a successful economy** taking steps to make the county a good place to do business, for people to live, work, study and visit, and to ensure that our schools are focused on raising the skills, qualifications and ambitions of all people in the county.
 - 2. **Helping people to be more self-reliant** taking early steps to reduce or prevent people from becoming vulnerable or dependent on the Council and its services.
 - 3. **Smarter use of resources** ensuring that all its resources (financial, physical, human and technological) are used as effectively and efficiently as possible and support the development of resources throughout the community that can help deliver the Council's priorities.

3. Background.

- 3.1 Local Democracy Week is held every year in October with the purpose of:
 - strengthening links between elected representatives and their communities
 - increase participation in the democratic process
 - · involvement of citizens in community affairs
 - increase their knowledge of local democratic institutions and processes
- 3.2 With the Local Government Elections in May 2017, this year's Local Democracy Week (10-16 October 2016) was an appropriate time to begin preparations for the elections and to actively involve the electorate in the democratic process.
- 3.3 A similar event was held in 2011 and a total of 38 people attended the event which

was well received. The feedback from those attending was very positive with comments including "Very satisfied; this was a very well organised, enjoyable and informative event" and "I thoroughly enjoyed this session, it was informative and gave me a real insight into the role". Attendees also suggested other possible activities for the future Local Democracy events which included the shadowing of a councillor for a day. A number of the attendees were subsequently elected as BCBC Councillors.

4. Current situation / proposal.

- 4.1 Bridgend County Borough Council held Potential Candidate awareness sessions during Local Democracy Week which were attended by constituents of the County Borough of Bridgend. The sessions provided information and were not political. Potential candidates who required further information regarding political parties were signposted to political representatives outside of the events.
- 4.1.2 Each event took approximately three hours and was comprised of two parts. The first part outlined information about the role of the councillor and the functions of the Council. The second part provided information regarding how an individual becomes a candidate at the election and the processes for being elected.

4.2 Promotion and publicity

- 4.2.1 The Marketing and Engagement Team received positive interest from constituents of the County Borough from the advertising campaign which was publicised using the BCBC website, press releases, local media (Glamorgan Gazette and BridgeFM) and social media (Facebook and Twitter).
- 4.2.2 Other bodies such as the political groups and Town and Community Councils were informed of the event to encourage those councillors and party members that are already planning to stand as Borough Councillors.
- 4.2.3 The publicity for the events requested that those wishing to participate, register their interest in attending in the event and confirm that they were considering standing in the Local Government Elections in May 2017. At the end of the registration period over 100 people had registered to attend one of the events.

4.3 Location, timings and venue

4.3.1 The events were planned to be held in the Council Chamber which could facilitate approximately 60 people at each event. Sessions were held in the early evenings starting at approximately 6.00pm to provide a wider scope of access for those people interested in participating in these events and who were currently working or have childcare issues to consider.

4.4 Delivery

- 4.4.1 The sessions were delivered by the Corporate Director Operational and Partnership Services and supported by officers from Electoral and Democratic Services.
- 4.4.2 Additional support was also provided at each event by cross party representation

from existing councillors to utilise their "real-life" experience to bring the event to life for those attending. Elected Members were also involved in informal discussions during the break.

4.5 Outcomes

- 4.5.1 The summary of the feedback provided at the events is shown at **Appendix 1.** The key outcomes were as follows:
 - There were 33% women in attendance which is slightly higher than the existing range of gender balance across Local Authorities in Wales (20-30%)
 - 25% of attendees were aged under 45 compared to the 15% of our current members who are under 45.
 - 30% of attendees learned of the events from Facebook
 - 93% of those who provided feedback stated that their expectations were met and the remainder did not explain why their expectations were not met.
 - A wide spread of the event content was identified as being "most useful"
 - The issues identified for improvement would be considered for any subsequent "potential councillor" event or included in the information being provided to potential councillors.
 - Overall feedback was very positive.
 - The sessions provided useful information and assisted the potential candidates determine whether to stand or not.
- 4.5.2 The true outcome of these events will be determined during the election process for the Local Government Elections in 2017. The publication of the Notice of Poll on 25 April will enable Democratic Services to identify those constituents who attended these sessions and whether they stood for election or were elected.
- 4.5.3 An initial email has been sent to all registered participants of the event with the presentation and handouts. It is hoped that further information updates could be provided inform them of relevant Councillor and Council related information over the next few months.
- 5. Effect upon Policy Framework& Procedure Rules.

6. Equality Impact Assessment

6.1 The registration process event requested any potential candidates to identify any support needs that they had to enable them to fully engage during their attendance at the events. The needs of a number of registered attendees were assessed as necessary at each of the events.

7. Financial Implications.

7.1 The expected costs of the events will not exceed the initial budget commitment from the Member Development budget.

8. Recommendation.

8.1 That the Democratic Services Committee considers the initial outcomes from the Potential Candidate sessions and the ongoing activities leading up to the Local Government Elections in 2017. .
