Extra Care Waiting Lists

The waiting lists for the two new Extra Care schemes are now open. Applicants wishing to add their name to the lists should telephone Linc on 02920 474030 or 474754. There is certain Eligibility Criteria that applicants must meet.:

- You should ordinarily be 65 years of age or older.
- You should be a resident within the Local Authority area of the scheme.
- You will already have a plan of care and support from social services, for example, a package of care or direct payment in place or be waiting for an assessment by social services.
- You should be unable to continue to live independently in your current home without an enhanced plan of care and support.
- You should not have nursing care needs beyond that which would be provided by the Community Nursing Services.
- You should be willing to be financially assessed, and be able to pay the rent and service charges and support costs (with the assistance of Housing Benefit if applicable).

Your application will be jointly reviewed by Linc and social services. If you meet the agreed Eligibility Criteria you will be accepted on to Linc's waiting list.

Staff Consultation

A series of four meetings have been planned as part of the formal consultation with staff regarding the Extra Care proposals. The meetings have been held in February and March and additional one to one meetings will also be offered to staff to discuss their own individual circumstances. <u>Community Benefits: Work Placement</u> Iwan Tilly from Coleg Cymunedol Y Dderwen School has been enjoying a 4 week work placement at the Ynysawdre site. Pictured here with Justine Scorrer and Shelly Leonard from Linc, Iwan said "It is going really good, the best thing is not being indoors all day but the worst thing is the cold, my hands have been freezing. I want to go to college and study more about it, I might do a course in bricklaying or something'. Sian Bridge from Jehu Group said 'Iwan has being doing a great job, it is good to have him on board".
