Executive Summary:	This report presents the Welsh Government's final 'Statutory and Non-Statutory Guidance for Principal Councils in Wales', issued in June 2023, for the Committee's consideration of sections relevant to the role and remit of the Democratic Services Committee.

## 1. Purpose of Report

1.1 The purpose of this report is to inform the Committee of the Welsh Government's final 'Statutory and Non-Statutory Guidance for Principal Councils in Wales', issued in June 2023, with specific reference to how it relates to the work of the Democratic Services Committee.

## 2. Background

- 2.1 The Local Government and Elections (Wales) Act 2021 was passed by Senedd Cymru on 18 November 2020. It received Royal Assent on 20 January 2021.
- 2.2 The Welsh Government's stated purpose for the Act, as noted in its Explanatory Memorandum is to:
  - 'provide local government with new ways to support and serve their communities'; and
  - to 'reinvigorate local democracy in Wales'.

- 2.3 The Act makes changes to the legislative framework for local government elections, democracy, performance and governance. It seeks to reform and strengthen local government accountability, performance and transparency, and places new duties on principal councils to promote public participation in local democracy. The Welsh Government also anticipate that some of the provisions within the Act will encourage greater diversity in local government.
- 2.4 In January 2021 a report went to Council to highlight the 2021 Bill and also demonstrate how the Authority was planning on meeting its requirements with a detailed action plan.

### 3. Current situation / proposal

- 3.1 In June 2023 Welsh Government published the 'Statutory and Non-Statutory Guidance for Principal Councils in Wales', which consists of consolidated statutory guidance intended to meet requirements under the Local Government Act 2000, the Local Government (Wales) Measure 2011 and the Local Government and Elections (Wales) Act 2021.
- 3.2 This Guidance, attached at **Appendix A** includes:
  - Part 2 Guidance for elected members' support, training and development
  - Part 3 Guidance on public participation strategies and petition schemes
  - Part 4 Guidance on constitutions, executives, scrutiny, governance and audit committees and conducting meetings.
- 3.3 The remit of the Democratic Services Committee does not cover all aspects of the guidance and therefore the main areas that are within the Committee's remit are highlighted below. Other committees will receive updates on the guidance which is within their remits:
