### **Constituency Activity**

I was elected to Bridgend County Borough Council to represent the Garw Valley including being appointed to several committees.

I have supported the residents on my ward on a variety of issues and have formally raised over 117 constituent queries according to my records, this is regarding BCBC and other organizations.

This is in addition to informally addressing a number of other issues which you have asked me to resolve. I don't record phone calls or messages left on my phone but sometimes they can be quite a few.

To enable me to fulfil my role as your representative, I have attended a number of Member Development activities which have assisted me to ensure that my knowledge of national and local issues affecting the Council and my ward is maintained.

During the period I have attended several meetings with several Sports Clubs, Llangeinor Football Club and Pontycymmer Rugby Club to discuss the progress of their CAT applications.

As a member of the Development and Control Committee I have attended several site visits within my area.

I run a Coffee Morning in the OAP Centre once a week, so if anyone has any queries, questions, gripes they know where to find me.

The PCSO's try to make it a regular pit stop and let us know what is happening in the area.

As the area is quite diverse it covers Blaengarw, Pontycymmer, Pontyrhyl, Llangeinor and Bettws I regularly drive around checking complaints that I have received and checking what progress, if any has been made.
