## Fully funding of National Policy Commitments – Housing and Homelessness

I am writing to formally put on record the concerns of our Subject Overview and Scrutiny Committee 2 which met on 14 November 2024 to consider the Authority's Annual Corporate Safeguarding Report 2023-24.

During discussions, Officers advised that during the COVID-19 pandemic, emergency legislative guidance from Welsh Government was introduced leading to increased statutory duties on local authorities to provide temporary accommodation.

Officers confirmed that the legislative change is now permanent and, as such, is impacting on the number of placements, exacerbated by wider issues such as the cost of living crisis and the particularly challenging private rent market are causing both increase in demand and making it harder for households to move on from temporary accommodation.

Whilst during the emergency measures, the local authority was able to largely recover their costs through the Hardship Fund, following the legislation becoming permanent, the cost of

I have been asked by Subject Overview and Scrutiny Committee 2 to express the Committee's concerns about the impact of not fully funding WG national policy commitments upon the Authority's budget and services.

The Committee requests that due consideration be given to the above and look forward to your response.
