Executive Summary:	To advise the Joint Committee of a recent article published by the Royal Society of Architects in Wales.

1. Purpose of Report

1.1 The purpose of this report is to inform the Joint Committee of a recent article published by the Royal Society of Architects in Wales in the Society's Touchstone Journal 2024, about the Crematorium's Flower Court extension (**Appendix A**).

2. Background

- 2.1 At the meeting on 15th June 2018 the Joint Committee approved the provision of a structural extension to the Flower Court facility by extending the rear of the Crematorium building onto the current grassed area outside the exit doors of Crallo Chapel, in order to address the bottleneck that was created when large congregations filed through one set of doors and into the limited narrow corridor space of the Flower Court. Additionally, the delay that was caused to the following funeral service as a result of the slow movement of the congregation through this area.
- 2.2 Architect Mr Jonathan Adams, Percy Thomas Architects, was placed in charge of the design works. Mr Adams is a Welsh architect, well known for his landmark buildings in Cardiff and was previously President of the Royal Society of Architects in Wales (RSAW) from 2005 to 2007. His notable projects include the prestigious Millennium Centre in Cardiff Bay, the new headquarters building for the Welsh Joint Education

Committee (WJEC) in Llandaff and the Sherman Theatre refurbishment in Cardiff.

- 2.3 At the meeting on 14th June 2019, the Joint Committee approved the proposed design of the extension to the Flower Court facility and authorised the application for planning permission and invitation of tenders in respect of the works to be undertaken. The provision of funding for the project would be accommodated in the Crematorium's accumulated reserve funds.
- 2.4 Works commenced on 3rd October 2022. The project was managed on behalf of the Crematorium Joint Committee by the architect, Jonathan Adams and the client officer, the Bereavement Services Manager and Registrar, Joanna Hamilton. The Flower Court extension opened to the public in November 2023.

3. Current situation / proposal

- 3.1 The Touchstone Journal is the Journal for Architecture in Wales, published by the Royal Society of Architect's in Wales.
- 3.2 The 2024 Journal includes an article on pages 12-15 entitled "Respect for the departed", which details the original architecture of the Crematorium and the new Flower Court extension (**Appendix A**).
- 3.3 The article praises the exceptional design of the new Flower Court and highlights the level of quality of the build being assisted by the positive relationship formed between the architect and client officer.
