1	Members expressed concern regarding the significant pressure on Youth work and Youth Justice being dependant on Grant Funding and the Committee recommended that the Leader / appropriate Cabinet Member contact the three Members of Parliament who represent the constituencies across Bridgend County Borough, to clarify the stage of the funding bid made to the Youth Endowment Fund.	The Youth Endowment Fund finance concludes on 31st August 2025. The Home Office have provided £178k funding until March 2026 through the Violence Reduction Unit, for some limited continuation of the trauma project. The first 6-month post project evaluation findings report is due to be produced by the end of October 2025 and there will be a follow-up 12-month evaluation report produced by April 2026.  Youth Justice concerns regarding temporary grant funding have been raised to the Welsh Government by Youth Offending Team Managers Cymru (YMC) to Lynzi Jarman (Welsh Government Youth Justice advisor). The services have jointly examined police data sets on crimes within the authority for the month of December 2025 to optimise service delivery. The services now have an adjoined prevention panel for any referrals requiring prevention support and that enables a combined preventative offer of support which aims to offer relevant intervention at the right point by a wide range of preventative services. 4	The Committee <b>recommended</b> that future reports relating to Bridgend Youth Service and Youth Justice Service include the Third sector as part of provision in Bridgend, explore the financial support provided to the Third sector and that a Third sector representative be invited for such reports.
