

# Plagiarism Guidelines (including use of Artificial Intelligence)

## Before presenting a task:

At the beginning of any piece of coursework / non-exam assessment, the teacher is required to:

- familiarise themselves with the rules and conditions of the task, including any resubmission opportunities (see the subject specification / Non-Exam Assessment (NEA) documentation to ensure the NEA guidance is always followed by teachers)
- familiarise themselves with 'A Guide for Centres' general instructions and 'Instructions for Conducting Controlled Assessments' from WJEC.
- consider the administration of the task, for example, digital requirements, is it necessary to lock a Teams assignment, set up an exam account/file etc.
- NEA storage must be considered for hard copies, candidate work should be stored in a secure place that pupils are unable to access.
- explain the conditions of the task / controlled assessment to all candidates.
- show the Joint Council for Qualifications (JCQ) malpractice and plagiarism presentation, drawing particular attention to the section on AI

- reinforce correct referencing guidelines when completing work.
- set timely deadlines that allow sufficient time to assess the work, return the mark and provide the period for appeal before submitting the mark in accordance with JCQ guidelines.

## All teaching staff must/will:

- be vigilant with regards to candidate misconduct and be aware of the JCQ regulations AI Use in Assessments: Protecting the Integrity of Qualifications
- assess/monitor the work continuously, if the specification allows, to identify and respond to any concerns in a timely manner.
- not accept work which is not the student's own. (JCQ)
- only be able to assess work that is the student's own work.
- must ensure that the learner understands the implications of the declaration of authenticity document and that the learner's statement is signed **before submission of the final piece of work**.
- report any suspicion, accusation or incident of misconduct to Head of Department / Senior Leadership Team (SLT) following the school policy.

Teacher suspects plagiarism or malpractice where statement is unsigned.



Discussion with Subject Lead.



- Meet and discuss with the learner.
- Transfer comments to school MIS as a log.
- Contact parents-carers to inform them of the concern.
- Head of Year is informed for information at this point.

- Explain to the parents-carers and pupil that the department (with a member of SLT) will carry out an investigation and make comparisons across a range of work.
- Hold further discussion(s) with the learner to check understanding of what was presented.

- SLT communicates to parents-carers explaining the next steps with the work involved and cross-subject investigation.

- Letter/email to parents-carers from the senior leader/SLT link for exams explaining the outcome.

- Email to the parents-carers and Head of Year (from the relevant SLT member) explaining the results of the wider investigation listing any work that needs to be resubmitted or where marks cannot be awarded.
- Notify the Headteacher.

- If a parents-carers/learner appeals the decision, the school will arrange for an independent subject specialist to look at the work.
- The cross-subject investigation will continue during this period.



- SLT collaborates with the Subject Lead to identify any potential modifications to the departmental guidance to further reduce the risk of plagiarism and malpractice.
- Report findings to the Headteacher.

## SUMMARY OF JCQ GUIDELINES

All Subject Leads are required to be familiar with the guidelines below together with the school's policies and guidelines, ensuring that the content is understood by all members of the department who administer non-examination assessments

### AI Use in Assessments: Protecting the Integrity of Qualifications

“AI use refers to the use of AI tools to obtain information and content which might be used in work produced for assessments which lead towards qualifications”. “In signing the learner declaration, the learner states that the work submitted is their own, using their own words and has not been copied or paraphrased from another source, including AI. Learners should be able to discuss any work submitted demonstrating a good understanding of the information and skills included”.

“AI misuse constitutes malpractice as defined in the JCQ Suspected Malpractice: Policies and Procedures (<https://www.jcq.org.uk/exams-office/malpractice/>). The malpractice sanctions available for the offences of ‘making a false declaration of authenticity’ and ‘plagiarism’ include disqualification and debarment from taking qualifications for a number of years. Students’ marks may also be affected if they have relied on AI to complete an assessment and the attainment that they have demonstrated in relation to the requirements of the qualification does not accurately reflect their own work”.

“Teachers, assessors and other staff must discuss the use of AI in qualification assessments and agree their approach to managing students’ use of AI in their school, college or exam centre. Centres must make students aware of the appropriate and inappropriate use of AI, the risks of using AI, and the possible consequences of using AI inappropriately in a qualification assessment. They should also make students aware of the centre’s approach to plagiarism and the consequences of malpractice”. Where work must be completed digitally staff must be vigilant, adhering to the guidance to minimise risk e.g. AB tutor, blocking access to the internet etc.

“Where AI tools have been used as a source of information, a student’s acknowledgement must show the name of the AI source used and should show the date the content was generated. For example: ChatGPT 3.5 (<https://openai.com/blog/chatgpt/>), 25/01/2024. The student must retain a copy of the question(s) and computer-generated content for reference and authentication purposes, in a non-editable format (such as a screenshot) and provide a brief explanation of how it has been used”.

Teachers must monitor work closely making comparisons with the learner's other pieces of work to identify malpractice, showing consideration for spelling and punctuation, grammar, writing style and tone, vocabulary, complexity and coherency, general understanding etc. Teachers should be confident that the work submitted is that of the learner before signing the teacher declaration.
