The Committee were advised of the interconnectivity between all Council Directorate budgets and recommended that consideration be given to adding a section to future budget reports to include an all Council-contextual overview before detailing individual Directorate positions.

	Additional Information Requested 3. Members requested a breakdown of the value for each anonymised schools' projected deficit or surplus budget and that consideration be given to including this information in future Budget reports. 4. The Committee were advised that the Committees Directorate are implementing a new Integrated Work Management System and requested that Communities, Environment and Housing Overview and Scrutiny Committee consider requesting a report regarding the new system. 5. The Committee discussed the ongoing review of the Council's Cemeteries Strategy and requested that consideration be given to exploring: a. whether cemeteries should be considered by a Joint Committee building on the success of Coychurch Crematorium; and b. alternative burials such as natural and hydro given that cemetery space is limited. 6. The Committee discussed the cessation of the Council's Pest Control Service and requested information regarding the number of complaints regarding pests since October 2025, set out by Ward if possible. 7. The Committee discussed the shortfall on Department for Work and Pensions' subsidy contributions towards housing benefit payments and requested more information regarding the number of cases supported, detail and impact of those costs and the number of any legacy cases which may be having an impact. 8. The Committee discussed the grant funding received by the Service to assist refugees and those seeking asylum and requested: a. the level of grants received in previous years, and the level anticipated to continue in future years; b. an update on outcomes achieved from the grant funding received and the numbers being supported by the Authority, set out by Ward if possible; and c. an all-Member briefing regarding the support offered by the Service.
