Thus, we contacted to the licensing department regarding with this matter. I was spoken with Miss Evans on the phone, she advise me to write to the licensing department about this matter and explained the issues has been arise between the police. Some reason police are not happy with that we open to the shop till 00:00 midnight even. However, we have a license open till late night. We are really glad about police try to protect public and prevent to crime.

However, we do not understand, why does police keep visiting our shop many times and keep asking to us that why does the shop open? Even, we have a license to open shop as 9:00 – 00:00 a.m. on Sundays to Thursdays, and 9:00 – 2:00 a.m. (morning) on Fridays to Saturday s. However, police has been visiting to our shop within this time periods and warned to us until we provide them our license. Then after they just leave to the shop could not say anything. However, some reason they have kept doing this. For instance, on 24/01/2015 at 1:30 a.m. they came outside to the shop again and taken to our pictures, even we have got a license to open shop till 2:00 a.m. The police are try to revoke our license and written to us last week. Into the letter says that they have been warned to us in May 2013 and also, on 30 December 2014. Also, they have been warned to the previous owner of the shop in 2011, who is . I just wondering that why the police are trying to punished us regarding with the faults of previous owner?

Another reason is that they alleged that we do not provide them CCTV record on 30 December 2014. Even, we send them and explained the issues to the police, as the CCTV is not working properly. Thus, recently it is got some problem again, so we contact to the provider of CCTV is going to change as soon as possible. You will have a copy of the letter enclosed of this letter which is we sent to the police.

On the other hand, all these issues a side, I try to work very hard to survive in this country. I want to work as much as can work, and earn money to look after my family members. I work hard and serve

to drunken people till 2:00 a.m. As you know that when people drunk, they are not polite. They swear and talking rudely. If, I have a choice of course I am not prefer to work and serve this drunken people till 2:00. However, I have not got another choice; I am a foreign citizen in this country. I have not got much choice. This is my job, albeit I am not happy with that, but I need to survive and look after my family. I do not claim benefit from Government and sitting at home all day as layze people I do not want to the Government look after me and my family members, instead of this I want to work as much as I can work. Although, I prefer to pay the tax, bills, and rent, and I try to pay Government as much as I can pay. Also, indirectly I pay to police by paying the tax and bills, e.g. Thus, I am expecting that police are care about me and battle for my rights, not interference me to work and pay to the tax, e.g.

The other crucial issue is that when the police keep visiting to the shop is affect my profit, because of its bad reputation. After the police has been visiting to the shop my regular customers asking me that why police are keep visiting you every time? Even, I have not got an answer to reply the customers' questions. The reason is that I do not know, what reason is the police keep visiting to the shop every often recently. If, police are not happy with us to open the shop's late. At this point, I just wondering that there are another 3 shops are open late midnight, why they are open late midnight. For instance, there is one kebab shop opposite to us and they are always close late. Even, they have not got license to open late. I have make complaint about them; however, no one dealt on it. I called to police many time, police told me this is not their job and you need to call to the council. Although, they keep visiting us for this matter many time. I am getting really confuse about it, why does police not consider our complaint.

Furthermore, the other crucial issue is that if you will revoke my license, it will effect on my profit and shop. Accordingly to this I could not manage to pay bills, tax, rent, and wages of the employees. Thus, I could not afford to pay my own expense and my family as well. It's a worse scenario, but it could be happened after all this events, if the business will not running well after revocation it could be closing down. Therefore, I could not pay tax to the Government and also I and my staff lost their jobs. So, we will all claims benefit from government. I just wondering that what is police aim to interference us to work? Even, we want to work and look after ourselves and pay to the tax.

I want to point out at this stage; I do not want to blame police. I understand that police try to protect public and prevent to crime. I am really proud of the police try to protect me as well as much as other public member. I am not disagreeing with police's idea. Also, I am really happy to financially support to police, you will receive a copy of receipt enclosed of this letter. We just a request from police helps us when they will consider on this matter, please deal on it we try to work hard to survive.

Although, we request your helps, when you deal on this matter, we try work hard to survive and look after our families members. Already, we lost some profit after wetherspoon. If, you revoke to the license we will lose more profit, after that we will close to the shop. When, you consider on this case, please deal on all those issues as well. I will respect to your decision, whether it will be a positive or negative. I will not judge your decision, however I need your help for survive and look after my family, and also my staff need this job as well.
