Report Title:	PROGRESS AGAINST THE INTERNAL AUDIT RISK BASED PLAN 2026-27

Policy Framework and Procedure Rules:	The proposals in this report are in accordance with the policy framework and budget.
Executive Summary:	• The progress made against the internal audit plan as of 31st August 2026 is detailed in Appendix A. Table 1 summarises that 13 planned audit reviews have been completed to at least draft stage which equates to a completion rate of 33%. • An audit opinion, based on the assessment of the strengths and weaknesses of the areas examined through testing of the effectiveness of the internal control environment is applied to completed audits. To date all 13 audits have had <i>Substantial or Reasonable Assurance (100%)</i>, no <i>Limited Assurance</i> opinions have been given. • Included within the 2026-27 plan are 5 audits that were not undertaken or completed in 2025-26. Appendix B shows that 4 of these audits have now been completed. • A total of 55 recommendations have been made to date to improve the control environment. The progress being made in implementing the high and medium risk recommendations is regularly monitored by the Audit team and reported to this Committee.

1. Purpose of Report

- 1.1 To provide members of the Committee with a position statement on progress being made against the audit work within the approved Internal Audit Risk Based Plan 2026-27.

2. Background

- 2.1 In accordance with the Global Internal Audit Standards, the Head of Audit is responsible for developing a risk-based annual audit plan which considers the Council's risk management framework. Within the Standards there is also a requirement for the Head of Audit to review and adjust the plan, as necessary, in response to changes in the Council's business, risks, operations, programmes, systems, controls and resources. The Head of Audit must also ensure that Internal Audit resources are appropriate, sufficient and effectively deployed to achieve the approved plan.
- 2.2 The Internal Audit Plan for 2026-27 was submitted to the Governance and Audit Committee for consideration and approval on 18th June 2026. The Plan outlined the assignments to be carried out which will provide sufficient coverage to provide an overall opinion at the end of 2026-27.
- 2.3 The plan is flexible to allow for changing circumstances and events that may occur, such as requests to respond to new issues that may emerge.

3. Current situation / proposal

- 3.1 Progress made against the approved plan for the period 1st April 2026 to 31st August 2026 is attached at **Appendix A**. This details the status of each planned review, the audit opinion and the number of any high, medium or low-priority recommendations made to improve the control environment, as well as the date each final audit report has been issued. It should be noted that some reviews listed have no audit opinion, for example advice and guidance and Governance and Audit Committee / Corporate Management Team reporting, Fraud, Error or Irregularity. This is because the audit work carried out in respect of these items is planned but the nature of the work does not lead to testing and the formation of an audit opinion, although in some instances recommendations are made.
- 3.2 The Regional Internal Audit Service (RIAS) has set quarterly targets to monitor the delivery of the approved audit plan. This will assist in ensuring sufficient audit coverage has been given to the Council to provide an overall opinion at the end of 2026-27. The targets that the RIAS are working towards at the end of each quarter are as follows:
- Qtr 1 = 10%
 - Qtr 2 = 30%
 - Qtr 3 = 50%
 - Qtr 4 = 80%
- 3.3 As of 31st August 2026, the level of coverage was 33% which is exceeding the target of 30% for the end of quarter 2. A summary of the progress made to date is shown in **Table 1** below. Details of individual audit assignments are shown in **Appendix A**.

- 3.4 An audit opinion is applied to an audit based on the assessment of the strengths and weaknesses of the areas examined during the audit through testing of the effectiveness of the internal control environment. **Table 2** shows the audit opinions given to the 13 completed audits; all have been given a *Reasonable Assurance* or *Substantial Assurance* opinion; there have been no *Limited Assurance* opinions. Details of individual audit opinions are shown in **Appendix A**.

- 3.5 For reference, the audit assurance/opinion categories are:

AUDIT ASSURANCE CATEGORY CODE	
Substantial	A sound system of governance, risk management and control exists, with internal controls operating effectively and being consistently applied to support the achievement of objectives in the area audited.
Reasonable	There is a generally sound system of governance, risk management and control in place. Some issues, non-compliance or scope for improvement were identified which may put at risk the achievement of objectives in the area audited.
Limited	Significant gaps, weaknesses or non-compliance were identified. Improvement is required to the system of governance, risk management and control to effectively manage risks to the achievement of objectives in the area audited.
No Assurance	Immediate action is required to address fundamental gaps, weaknesses or non-compliance identified. The system of governance, risk management and control is inadequate to effectively manage risks to the achievement of objectives in the area audited.

- 3.6 The audit plan 2026-27 includes audits that were not started during 2025-26 or were incomplete at year end. There are 5 of these and their status is identified at **Appendix B** which shows 4 of the 5 have been completed to at least draft stage.
- 3.7 **Appendix A** shows that a total of 55 recommendations have been made to date to improve the control environment: 1 high priority (2%), 28 (51%) medium priority and 26 (47%) low priority. The implementation of the high and medium priority recommendations are regularly monitored by the Audit Team to ensure that the identified and agreed improvements are made. More detailed information is included for Committee in the separate Recommendation Monitoring report.
- 4. Equality implications (including Socio-economic Duty and Welsh Language)**
- 4.1 The protected characteristics identified within the Equality Act, Socio-economic Duty and the impact on the use of the Welsh Language have been considered in the preparation of this report. As a public body in Wales the Council must consider the impact of strategic decisions, such as the development or the review of policies, strategies, services and functions. This is an information report, therefore it is not necessary to carry out an Equality Impact assessment in the production of this report. It is considered that there will be no significant or unacceptable equality impacts as a result of this report.

- 5.1 The well-being goals identified in the Act were considered in the preparation of this report. It is considered that there will be no significant or unacceptable impacts upon the achievement of well-being goals/objectives as a result of this report
