

Annex 1 - Mandatory Conditions:

- 1. No supply of alcohol may be made under the premises licence:
- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;



- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink BRIDGEND without assistance by reason of disability).
- 4. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 5. The premises licence holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- 6. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 7. The responsible person must ensure that-
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- 8. The Licensing Act 2003 (Mandatory Conditions) Order 2014 applies to relevant premises licences. (Permitted price of alcohol). A copy of the relevant document setting out the mandatory condition can be found at www.legislation.gov.uk.

- 9. Where one or more individuals must be at the premises to carry out a secuirty activity, each such individual must be licensed by the Security Industry authority.
- 10. The admission of children aged under 18 to the exhibition of any film is to be restricted in accordance with any recommendation made by:

 a)the film classification body designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) or b)the relevant licensing authority.

Annex 2 - Conditions Consistent with the Operating Schedule

General - All four licensing objectives:-

- 1. This Premises Licence Holder will continue to train its staff required by relevant legislation.
- 2. No disorderly conduct shall be permitted therein or any exhibition, recitation, acting, singing or dancing which is of an obscene character or offensive.
- 3. Explosives, inflammable liquids or highly inflammable articles shall not be permitted on the premises without the consent of the Licensing Authority.
- 4. No structural alterations or alteration to the layout of the premises including ceiling and wall linings shall be carried out without the consent of the Licensing Authority.
- 5. No exhibition, demonstration or performance of hypnotism (as defined in Section 6 of the Hypnotism Act 1952) shall be given by any person at the place licensed except with the express written consent of the Licensing Authority and in accordance with any conditions attached to such consent.
- 6. An application for consent under Condition 15 (a) shall be in writing and signed by the Licence holder or his agent and shall be made not less than 28 days in advance of the exhibition, demonstration o performance concerned. A copy of the application shall at the same time be forwarded to the Superintendent of Police and the South Wales Fire Service.
- 7. The parts of the premises licensed for public entertainment and the maximum number of persons permitted to resort to those parts are as follows:-

Ground Floor



Internal area - 875 persons External area - 40 persons (these are not in addtion but taken from the above figure of 875)

First Floor - 220 persons

- 8. The Premises Licence Holder shall at all times maintain a register of security personnel employed on the premises, such personnel to hold current registration as a door supervisor with the Security Industry Authority.
- 9. The size of the proposed dance floor in respect of the first floor shall be not smaller than 10ft by 10ft and that should the proposed dance floor be portable, then it be adequately secured when in use.

The prevention of crime and disorder:-

- 1. The Premises Licence Holder will ensure that a risk assessment is carried out to determine the number of door staff who shall be on duty for each public opening.
- 2. The Premises Licence Holder will ensure that 13 camera digital CCTV system with 10 internal and 3 external cameras will operate during trading times with a hard drive memory of one month.
- 3. The Premises Licence Holder will ensure that notices stating that CCTV is in operation 24 hours a day will be displayed throughout the venue.
- 4. The Premises Licence Holder will ensure that any person who appears to be intoxicated or who is behaving disorderly will not be allowed entry to the venue. Any person within this venue who appears to be intoxicated or who is behaving disorderly will be given care and consideration in leaving the venue.
- 5. The Premises Licence Holder will ensure that the venue actively participates in the local Pubwatch or equivalent scheme.
- 6. Where already used text/radio pagers will continue to be used for the additional hours of trading and will be monitored by a responsible member of staff.
- 7. The Premises Licence Holder will ensure that toughened glass is used during hours of trading.
- 8. The Premises Licence Holder wil ensure that only photographic driving licences, passport or in agreement with the Police a form



of identification with the PASS hologram will be accepted as proof of age.

- 9. The Premises Licence Holder will ensure that an SIA registered doorman supervises the external area from 2000 hours.
- 10. The Premises Licence Holder will ensure that the external seating area will not be used for the consumption of alcohol after 0400 hours.
- 11. There is a first aid/security room available for the searching of customers and where appropriate and legally permissible, the holding of customers whilst the Police are called.
- 12. When the venue hols occasional events which may involve striptease, the Premises Licence Holder will ensure:-
 - 1. Any such event would be a designated event where the artists would be under the supervision of the Designated Premises Supervisor or a Personal License Holder and in an area which would have additional allocated security.
 - 2. There will be no exposure of genitalia and no contact of a sexual nature between artist and any member of the audience.

Public safety:-

- 1. The Premises Licence Holder will ensure that a person trained in first aid will be at the venue who will have received training in any problems associated with alcohol and drug misuse.
- 2. The Premises Licence Holder will ensure that a qualified first aider shall be present throughout any sporting entertainment involving boxing, wrestling, judo, karate or sport of a similar nature.
- 3. Where a ring is used it will be constructed by a competent person and shall be inspected by a competent authority before use and any material used to form the skirt of the ring shall be flame retardant.
- 4. The seating layout shall be agreed with the appropriate authorities.

The prevention of public nuisance:-

1. The Premises Licence Holder will ensure that if a DJ is used on any night then he/she will ask customers to leave quietly.



- 2. The Premises Licence Holder will ensure that reasonable steps are taken to recognise the need of local residents and businesses.
- 3. The Premises Licence Holder will ensur that litter is collected by members of staff after trading has finished for at least 15 yards either side of the premises.
- A lobby is provided to the main entrance to prevent noise emission.
- 5. Air conditioning is provided within the premises.

The protection of children from harm:-

- A person under the age of 18 years will only visit the venue with a responsible adult usually for the purpose of dining unless there is an event especially organised for the youth market. Unaccompanied persons under the age of 18 are not welcome in the venue except at events especially organised for the youth market.
- 2. The Premises Licence Holder will ensure that when the venue holds specially organised events for the youth market, the venue will be adhere to the following attached documentation:-
 - 1. Admission policy.
 - 2. General Policies Statement.
 - 3. Code of Conduct for Staff Statement.
 - 4. Child Protection Policy.
- 3. If the venue holds occasional events which may involve a striptease or an act involving hypnotism, the Premises Licence Holder will ensure that no persons under 18 years are admitted to the premises.

Annex 3 - Conditions attached after a hearing by the licensing authority:

- 1. There shall be no admission/re-admission after 0230 hours.
- 2. Non-glass receptacles will be used in the new external area at all times.
- 3. Wheelie bins will be secured and contained within the curtilage of the building (except on collection/emptying days).

- 4. Collection day for wheelie bins to be notified to the Police. Any changes to this day will also be subject of written notification to the Police.
- 5. The rear wall of the smoking area (the physical external wall of Sax Nightclub) to have a ledge type surface permanently fixed to the full length of the smoking area for the placement of plastic drinking vessels.
- 6. Four tall cafe bar type tables to be placed and secured during operational hours directly inside of the front enclosure closest to the public footpath to which tall chairs are required to be placed with. (The Premises Licence Holder will provide a reasonable number of chairs in respect of each said table).
- 7. Adequate numbers of purpose built bins will be provided for discarded cigarettes.
- 8. An SIA registered door supervisor to permanently man the internal area of the smoking area from 2300 hours until the close of trade to ensure that no members of the public gain access to the venue by entering the area that would be in breach of the premises licence conditions, e.g. under-age or members of the public attempting to gain entry after 0230 hours.
