#### Disabled children's short breaks consultation

It is proposed to amend the current overnight short breaks service provided at Baker's Way, Sarn in order to deliver a more appropriate service which is based on needs, and to make better use of the resources available.

Under the current model the property is underutilised with occupancy levels only at circa 65 per cent in 2015/16. This underutilisation adds additional costs to the service whilst also impacting negatively on the children and young people's experience of social interaction when using the service, which is a key part of their care & support plans when using Baker's Way.

After an initial consultation with users, parents, staff and interested residents of the borough 97 per cent were supportive of a remodelling of the service.
