**I am making a declaration of interest regarding NDR. I am a director and 50% owner, by shares, in AMV Services Limited, and AMV Services Holdings Limited.**

**AMV Services Limited owns, and operates, from two industrial units on Bridgend Industrial Estate, Bridgend.**

**AMV Services Limited received two payments of £10,000. One per property from the Government Small Business Covid-19 grant scheme, administered by Bridgend County Borough Council (BCBC).**

**As a director of AMV Services Limited, I made an application to the taxation department, for additional support and rates relief as we are not trading due to restrictions on large gatherings, as the business is an events related business. Additional relief was granted, so no NDR become due in the 2020/21 financial year.**

**Both requests, for the initial grant, and subsequent rates relief were made under the company legal entity, and not as an individual, or associated to my role as a councillor in this authority.**

**The grants and the opportunity to claim NDR relief are open, I believe to all qualifying businesses, and thus no special treatment has been gained as a result of my being a BCBC elected member.**
