CODE OF CONDUCT – Declaration of personal interests for inclusion in the public register of members’ interests

ADVICE TO COUNCILLORS:

The law, and the Council’s Code of Conduct, require you to declare personal interests. Some personal interests have to be recorded by you in the statutory public register, **within 28 days** of your election or appointment to office, and have to be updated by you **within 28 days** of any change.

(There is an exemption from having to declare “sensitive information”; the Monitoring Officer can advise you about this).
